AMENDMENT AND EXTENSION OF THE AGREEMENT BETWEEN WALLER COUNTY AND THOMPSON CONSULTING SERVICES, LLC

This Amendment and Extension of the Agreement (Year 2) is entered into and effective as of the date of the last signature affixed hereto ("Effective Date") by and between Waller County, Texas, a political subdivision of the State of Texas ("County"), and Thompson Consulting Services, LLC, with its principal place of business at 2601 Maitland Center Parkway, Maitland, Florida 32751 ("Contractor") (each referred to individually as "Party" and collectively as "Parties").

WHEREAS, County and Contractor are Parties to the original agreement ("Agreement") entered into pursuant to Request for Proposals 240417-30, approved by the Waller County Commissioners Court on May 29, 2024, and effective on June 3, 2024;

WHEREAS, the Agreement is subject to an option to renew for an additional one (1) year term;

WHEREAS, the Parties desire to amend the Agreement and extend the term for an additional one (1) year term; and

WHEREAS, Contractor requests a price increase for the current renewal term that aligns with changes to the Consumer Price Index for All Urban Consumers ("CPI-U");

NOW, THEREFORE, in consideration of the terms, conditions, covenants, and performance of the scope of work and services contained herein, as attached and made a part hereof, the Parties mutually agree that the foregoing is true and correct, and further mutually agree to amend the contract as follows:

SECTION 1. AMENDMENT

- 1.1 The Parties agree that the Term of the Agreement is hereby extended for a period of one (1) year beginning on June 4, 2025 and ending June 3, 2026 ("First Renewal Term"), unless terminated earlier under any provision of the Agreement.
- 1.2 The Parties agree that the Hourly Rate Schedules for services performed during the First Renewal Term shall be as identified in the column labeled "April 2025" in Tables G-1, G-2, and G-3 in Exhibit A, attached hereto and incorporated herein for all purposes.
- 1.3 The Parties agree that Amendment No. 1 entered into between the Parties on June 17, 2024 does not apply to the First Renewal Term.
- 1.4 Except as expressly modified herein, all other terms and conditions of the Agreement and each of the previous Amendments shall remain in full force and effect and continue to bind the Parties. If there is a conflict between this Amendment and Extension and the Agreement and/or any of the previous Amendments, the terms and conditions of this Amendment shall prevail.
