AMENDMENT AND EXTENSION OF THE AGREEMENT BETWEEN WALLER COUNTY AND DRC EMERGENCY SERVICES, LLC

This Amendment and Extension of the Agreement (Year 4) is entered into and effective as of the date of the last signature affixed hereto (“Effective Date”) by and between Waller County, Texas, a political subdivision of the State of Texas (“County”), and DRC Emergency Services, LLC, an Alabama limited liability company with its principal place of business at 6702 Broadway Blvd., Galveston, Texas 77554 (“Contractor”) (each referred to individually as “Party” and collectively as “Parties”).

WHEREAS, County and Contractor are Parties to the original agreement, entered into on May 10, 2023 pursuant to Request for Proposals 23-3-014, and approved by the Waller County Commissioners Court on that day;

WHEREAS, County and Contractor are Parties to a first extension term effective May 10, 2024, and approved by the Waller County Commissioners Court on April 17, 2024, and a second extension term beginning on May 10, 2025 approved by the Waller County Commissioners Court on May 28, 2025;

WHEREAS, the Agreement is subject to two additional options to renew, each for a one (1) year term; and

WHEREAS, the Parties desire to amend the Agreement and extend the term for an additional one (1) year period beginning on the May 10, 2026;

NOW, THEREFORE, in consideration of the terms, conditions, covenants, and performance of the scope of work and services contained herein, as attached and made a part hereof, the Parties mutually agree that the foregoing is true and correct, and further mutually agree to amend the contract as follows:

SECTION 1. AMENDMENT

- 1.1 The Parties agree that the Term of the Agreement is hereby extended for a period of one (1) year beginning on May 10, 2026 and ending May 9, 2027, unless terminated earlier under any provision of the Agreement. Following this Amendment and Extension, the Agreement shall be eligible for one additional one (1) year renewal period by written amendment and mutual approval of the Waller County Commissioners Court and DRC Emergency Services, LLC.
- 1.2 The Parties agree that Amendment No. 1 entered into between the Parties on June 17, 2024 does not apply to the extension agreed to herein.
- 1.3 Except as expressly modified herein, all other terms and conditions of the Agreement and each of the previous Amendments shall remain in full force and effect and continue to bind the Parties. If there is a conflict between this Amendment and Extension and the Agreement and/or any of the previous Amendments, the terms and conditions of this Amendment shall prevail.
