INMATE TELECOMMUNICATIONS AGREEMENT

Addendum Number 4

This 3rd Addendum, dated the ____ of _____, 2022, between Walton County and the Sheriff of Walton County of the one part, hereinafter "Sheriff," and Pay Tel Communications, Inc. of the other part, hereinafter "Pay Tel" modifies the Inmate Telecommunications Agreement dated January 8, 2002 as amended by the Addendum 1 dated April 25, 2005; Addendum 2 dated March 30, 2019; and Addendum 3 dated February 19, 2020 (collectively referred to as the "Agreement").

For and in consideration of the mutual promises and covenants contained herein, Pay Tel and Sheriff hereby agree to modify the Agreement as follows:

1. **3.0 Term.** The current term ending March 12, 2025, will be extended two (2) years, to and including March 12, 2027. After the renewed term this Agreement shall be automatically renewed for successive five (5) year terms unless written notice of intent to terminate is given by either party no more than 120 days and not less than 60 days prior to the expiration of the then current term. Notwithstanding the above, Sheriff reserves the right to cancel the Agreement without cause upon thirty (30) days' notice. Section 3.1 of the Agreement is deemed amended consistent with the foregoing


3. **5.0 Equipment and Services Provided by Pay Tel.** This section is hereby updated to reflect the following changes to paragraph 5.9, relating to the provision of tablets.

5.9 Pay Tel will upgrade the existing intelTABLET™ solution to provide sufficient equipment to accommodate a 1:1 ratio of inmates to tablets. With the expanded deployment, Sheriff agrees to permit full tablet access throughout the day and to continue to participate in the Quality Assurance Program with the goal of maximizing tablet access, managing tablet inventory and discouraging tablet damage. The tablet upgrade and expansion will be completed at no cost to Sheriff.

All other Agreement terms shall remain unchanged.
