I am the owner of 31,33 and 35 Main Street.

Please be advised I do not support outside dining in our Main Street parking spots and on Second Street.

- Our Main Street parking places and Second Street are for all the people of our town, deliveries and our guest to use.
- The dining spaces are not a safe place for dining due to the fact they are on the street. There is no way the wood structure will stop a car or truck from possibly injuring someone. Not to mention the dust, engine exhaust and road film on your food.
- The outside dining spaces create driving distractions and blind spots at our crosswalks, pedestrians could be at risk.
- The parking spaces used as dining areas are not attractive, all different and not the look the town needs.

- The outside dining areas are not maintained and cleaned up daily by their proprietors. This includes spilt food, cigarette butts, silver ware, napkins, plastic cups and trash.
- The town's street sweeper cannot clean the curb between the sidewalk and street with the dining structure in the parking space. Take a look, it stays a mess.
- There has been grease buildup on the sidewalks where food is delivered to outside dining by the restaurants. Another accident in the making.
