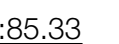
USGS Warrenton, VA Vicinity Map

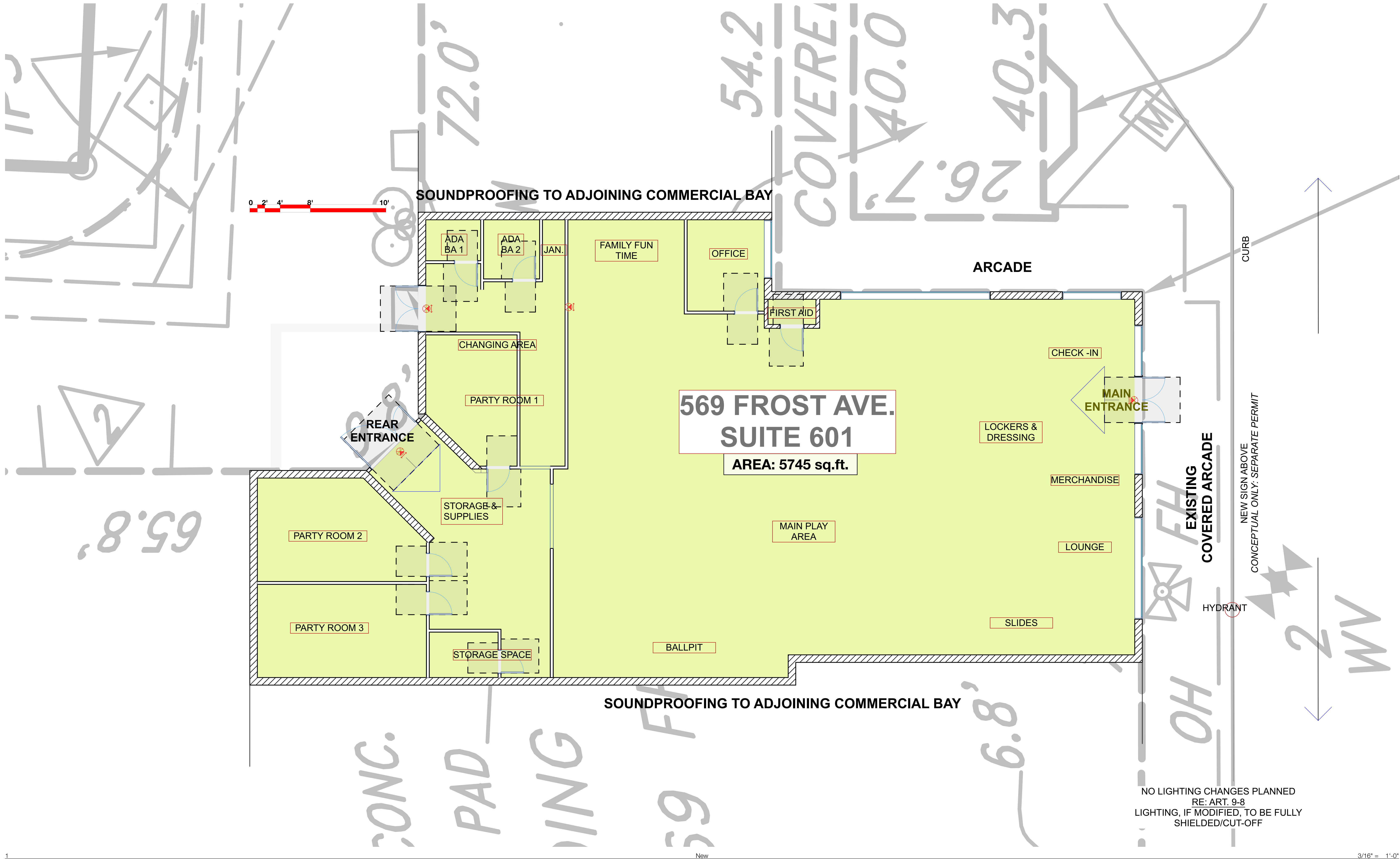

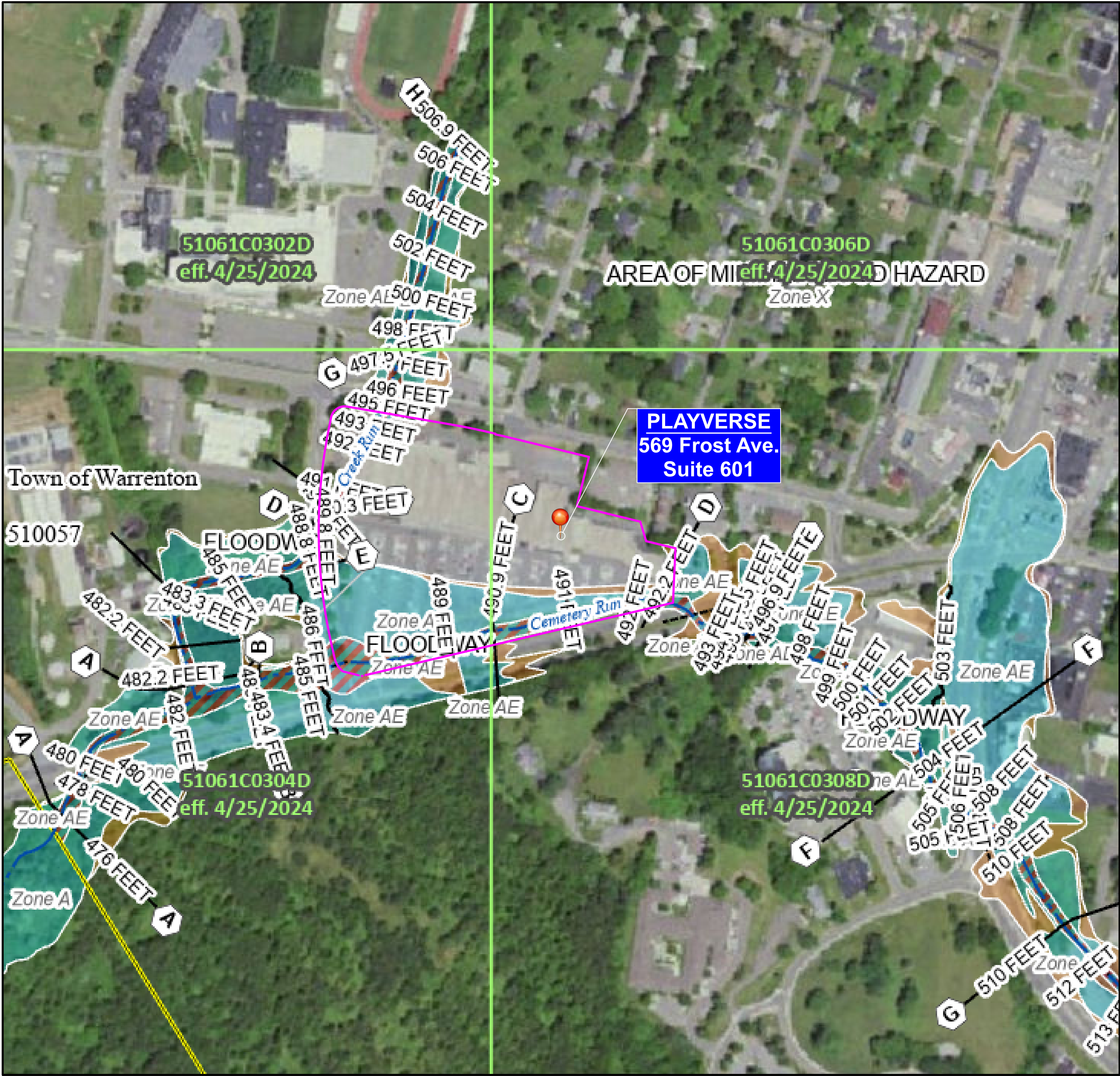




National Flood Hazard Layer FIRMette
