

Guidance in the *Manual on Uniform Traffic Control Devices* (MUTCD) suggests the posted speed should be within five mph of the 85th percentile speed of free-flowing traffic. Using this guidance, the following roadways would have 85th-percentile speeds greater than the posted speed limits:

- Foxcroft Rd.
- Piedmont St.
- Sycamore St.
- Blue Ridge St.
- Rappahannock St.
- Norfolk Dr.
- Dover Rd.
- Gay Rd.
- Fauquier Rd.
- Gold Cup Dr.



Safety Analysis

- 5-year VDOT crash data analysis (1/1/2018 to 12/31/2022)
- Evaluated the frequency, type, and severity of crashes
- 11 of 14 roadways did not have any crashes in 5 years
- Crashes: Gold Cup Dr., Blue Ridge St., Rappahannock St.
- 12 crashes on Gold Cup Dr. in 5 years; ½ resulted in injury
- No crashes had severe injuries
- Most crashes were angle crashes; 7 of 12 on Gold Cup Dr.
- 10 of 12 crashes on Gold Cup occurred between Norfolk Drive and US-17/Broadview Avenue



Conclusions

- 10 roadways experienced 85th percentile speeds greater than the posted speed limit
- MUTCD only provides "guidance" that speed limits should be posted at 85th percentile
- Seven of the 10 roadways experienced NO crashes during the 5-year review period
- Existing speed limits may be appropriate for these 10 roadways when taken in context with other factors specific to those streets
- The current speed limits on these streets "appear effective for most drivers" and "generally produce desired driver behaviors."
- A change of the posted speed limits to the 85th percentile may possibly cause higher speeds to occur
- More enforcement of the posted speeds <u>may</u> support more drivers observing the speed
