Please accept this as the quarterly report for the Emergency Services and Risk Management department.

Department introduction:

This is the fourth Departmental report for Emergency Services and Risk Management.

Emergency Services is responsible for all aspects of the Town's comprehensive emergency preparedness program. It involves planning, developing, reviewing, and revising emergency management program elements. It focuses on a collaborative partnership between local, state, and Federal partners in addition to community stakeholders pursuing a whole community approach to preparedness.

Risk Management is responsible for all aspects of workplace safety. It includes building and sustaining a Risk & Safety Program. In addition to planning, developing, and implementing occupational safety programs to ensure the health, safety, and security of Town staff and citizens. Risk management also focuses on the process of identifying potential hazards and mitigating their potential impact on the Town.

Training and Professional Development:

Training has a direct impact on an organization's productivity and performance. Training gives employees a better understanding of their responsibilities and the knowledge and skills needed to complete the job. Training will improve employee confidence which can positively impact performance.

- ELDT Course for Public Works and Public Utilities
 - The Entry-Level Driver Training course for Commercial Driver's Licenses (CDL) was kicked off on January 8th, 2024. 8 employees across Public Works and Public Utilities participated in the class which included rigorous online course study, field driving practice, and adherence to the regulations as set forth by the Federal Motor Carrier Safety Administration.
 - All 8 employees completed the course requirements to successfully pass the ELDT Training course which gave them the ability to test for their CDL. All 8 employees successfully passed the CDL License exam through the Virginia Department of Motor Vehicles.

Employees who work at the following locations, had reported zero instances across all criteria:






