#### **EXECUTIVE SUMMARY**

Town staff worked with NewGen Strategies & Solutions and Davenport & Company LLC to update the 2021 Water and Sewer rate study to account for increases due to inflation, human capital, and an overhaul of the Capital Improvement Program for the Town's Water and Sewer Utility. NewGen and Davenport presented their recommendations to the Town Council during a work session on May 9, 2023. The goal of the study was to recommend rates that would allow the Town to address the capital needs of the system while maintaining compliance with the adopted cash balance and debt service coverage ratio policies.

#### BACKGROUND

The rate study factored in current and projected operating expenses, available cash balances, and anticipated capital projects. The 2024 – 2029 Capital Improvement Program (CIP) for Water and Sewer totals \$80.2 million. The study showed that the required increase in rates for FY 2024 was 25% for Water and 22% for Sewer. The increase in a monthly bill for minimum usage will be \$4.37 and the increase for a median user (3,000 gallons per month) will be \$8.37.



NewGen provided the following comparison chart for monthly bills:

smallest meter size and 3,000 gallons of usage (median for Warrenton customers)

# STAFF RECOMMENDATION

Staff recommends that Council adopt Ordinance 2023-05 to set the proposed Water and Sewer rates, effective July 1, 2023.

## Service Level/Policy Impact

The adoption of the ordinance establishes water and sewer rates, effective July 1, 2023. The proposed rates will be factored into the budget for FY 2024 and will enable the Town to fund the Water and Sewer operating budget and year 1 of the 2024-209 CIP.

## **Fiscal Impact**

The proposed rates represent the first year of a multi-year recommendation from NewGen and Davenport for rate increases through FY 2029.

## Legal Impact

Water and Sewer rates may be increased only after holding a duly advertised public hearing as prescribed by Virginia Code § 15.2-107.
