Notes

First instance of the Black Lives Matter Vigil for Action at Courthouse Square. No counter-demonstrators. Event organizer expressed desire to hold vigil every Saturday until Labor Day.

During weekend of Sept. 12-13, letters denouncing the Black Lives Matter movement and those who support it were found taped to the doors of some area churches. No threats in the letters, just the content and method of Reports of Black Lives Matter signs on private property being destroyed/removed. In one instance, when the resident brought the sign inside and displayed it on the inside of a window, someone placed tape over the exterior of the window to block it and wrote "disgusting" messages on it. No threats, just vulgar and disturbing A concerned citizen spoke with an officer and requested information about the vigil. The citizen wanted to know if it was safe to be in the area during the vigil and how long the Town was going to allow the vigil to occur. The citizen also stated that BLM group members were putting up signs on poles and other surfaces in front of the WPD began making security for the vigil an overtime detail within the department.

A counter-demonstrator became involved in a verbal argument with a BLM group member when the counter-demonstrator attempted to intimidate the BLM member with his physical presence. Several (4) officers Gabriel Cardino, a member of ALM group, had an altercation with Jon Trevathan, a member of the BLM group, in the parking lot of 10 Courthouse Square during the weekly vigil in which Mr. Cardino was upset that Mr. Trevathan took a photo of Mr. Cardino writing down the license plate numbers of BLM members' vehicles. Mr. Cardino snatched the phone from Mr. Trevathan's hand and stated he would "take you (Mr. Trevathan) out" if he continued to take photos. Mr. Trevathan said he was going to get law enforcement involved and Mr. Cardino gave back the phone. Mr. Cardino later admitted to WPD officers that he grabbed the phone from Mr. Trevathan BLM submits its first special event permit application under the new Town ordinance requiring such - event Public Safety Plan prepared for the BLM weekly vigil

Josephine Gilbert of ALM complained that BLM had posters that were too large (not observed by police) and the number of participants on the BLM side was more than listed on the public safety plan (40). She was advised that the number listed on the public safety plan was an estimate for planning purposes. Ms. Gilbert also stated that Public Safety Plan updated

Jennifer Ragle, a participant of the ALM group, walked into the Red Truck Bakery (22 Waterloo St), videotaping with her cellular phone, and confronted the employees about allegedly providing refreshments to BLM group members and not ALM group members. The employees attempted to explain the store policy of providing free water and coffee to the BLM group members, which was put in place by the owner, and provided Ms. Ragle with the owner's contact information. Ms. Ragle was asked by the store management to stop recording inside the business and she refused. Ms. Ragle later claimed to a Warrenton PD officer that upon attempting to leave the store, a BLM member inside the store purposely blocked her exit from the store. The Warrenton PD officer Sgt. Pierce speaks with ALM members to advise them that they cannot attach flags to Town street signs Grey Toyota full-size SUV with a large American flag on a tent pole on the rear circles the block several times and Following the incident and posting on 2/25/23, the bakery received several threatening phone calls including one in which the caller stated they were "watching the bakery." This led to fear, anxiety, and panic from some long-time employees of the business who refused to come to work. Some of the employees were juveniles who worked at the bakery and whose parents later forbade them from going to work. Employees expressed frustration with the situation as they needed the income but were scared to come to work. The business owners Two different vehicles, at different times, begin to turn right from Main St. onto Alexandria Pike before stopping short of the crosswalk for pedestrians already 1/2 way across (walking eastbound).

Full-size SUV & mid-size sedan fail to stop for two pedestrians crossing in crosswalk from Court Street to north Josephine Gilbert complained that BLM members were standing on "our side of the street" down by the Old Jail Museum. Chief Carter spoke with those standing there and they were not with BLM but were local mediators who were standing on the sidewalk talking and present in case their services were needed. The mediators also

Jennifer Ragle, a participant of the ALM group, files an email complaint with me stating that she encountered "Greg", a participant of the BLM group, at a gas station on 3/11/23 on Rt. 29 (outside of Warrenton) while pumping gas and that he spoke to her "aggressively" and had a "devilish smile" while doing it. Nothing Ms. Ragle stated the Greg said amounted to a threat. I advised Ms. Ragle to report the incident to the Fauquier County Sheriff's Office. Jennifer Ragle, a participant of the ALM group, emailed Chief Carter to express that she received several threatening letters at her residence after posting the video about Red Truck Bakery to social media. She stated there was no return address on them and they were not signed. Since Ms. Ragle lives in Amissville, VA, I advised her to contact her local law enforcement agency and report the incident. Ms. Ragle would not state exactly what Gabriel Cardino accidentally dropped a sign, that he had leaning against his legs, into in the travel lane but picked it up quickly. Mr. Cardino was standing at the edge of the curb in front of GDC and was holding a large flag with Gray full-size SUV turns left from Main onto Alexandria Pike right in front of a mid-size SUV traveling straight on Main St. toward Waterloo St. Missed each other by about 4 feet. At the same time a small sedan turned right Grey Toyota full-size SUV with a large American flag on a tent pole on the rear circles the block several times and Full-size pickup truck, turning left from Alexandria Pike onto Main St., pulls out in front of a small SUV traveling westbound on Main St, causing it to almost come to a complete stop.

Small gray SUV, turning left from Alexandria Pike onto Main St., pulls out in front of a small red coupe traveling westbound on Main St., causing it to decelerate rapidly and almost come to a complete stop.

Officer had to leave the area due to a priority call at Fauquier Hospital requiring two officers.

Members of a citizen group called the "Kindness Project" met with Chief Carter to express their concern about the growing antagonistic behavior and hate-filled speech and actions of the ALM group toward the BLM group during the weekly vigil. They stated they were especially concerned about Jennifer Ragle who seemed to be stirring up outside interest in the vigil and whose tone in her regular social media posts and videos is

Jennifer Ragle sends an email on 4/10/23 to Greg Schumacher, chairman of the Fauquier GOP, and several others stating that the video she posted on social media was to make others aware that because Red Truck Bakery supplies, upon request, BLM members with free water and coffee that BLM is "fully backed by Bryan Noyes and his husband" (owners of the bakery). She said she "went to the Red Truck Bakery to simply document Mark Riley spoke with Lt. Arnold and stated that Gabriel Cardino was becoming extremely hostile and told Mr. Riley that if he saw him in the grocery store he would "shit on him".

On 4/15/23 Lt. Moran spoke with ALM members Bill Doeher and Gabriel Cardino about flags they were holding that were larger than the allowed sign size. Mr. Doeher initially refused to comply, even after having it explained to him that he could be cited. He stated his reason for not wanting to comply is that he didn't want the BLM Gabriel Cardino asks Lt. Moran about a BLM event member parking their vehicle on the paved Courthouse Square area while unloading before their event. Mr. Cardino asks Lt. Moran if he is "going to do something about this." Lt. Moran states the location is private property. Mr. Cardino states he will start parking in that location because it is more convenient for him (sarcastically and confrontationally). Three citizens talk to Lt. Moran about Gabriel Cardino, a member of the ALM group, was standing in the bed of his pickup truck, parked on Main Street near 7 Main Street, waving a very large flag at the beginning of the weekly vigil (10:00 a.m.). Lt. Moran spoke with Cardino and explained that he could not counter-demonstrate from that location and that his flag was too large. Josephine Gilbert sent an email to Greg Schumacher (Fauquier GOP chairman) stating the BLM group was "fraudulent" and "racist", stating the group was given "legitimacy in taking over our Court House Square since June 2020, events that began rioting and the antifunding of Police due to George Floyd." The remaining content Near miss between gray SUV and black pickup truck. Gray SUV was turning left onto Alexandria Pike from the Black full-size pickup truck, turning left from Alexandria Pike onto Main Street, stops in travel lane for several seconds. ALM group member steps out into the road in front of General District Court for no reason. A full-size SUV honks horn. Driver of Volkswagen sedan honks horn 6 times in support of ALM group then gives female police officers standing at corner of Main St. & Alexandria Pike "the bird" as he drives by.

Green station wagon turning right from Main St. stops within 5 feet of pedestrian crossing in crosswalk on

Driver of green station wagon stops very short of crosswalk while pedestrian is crossing from west to east along
Driver of small import vehicle turns left from through lane from Waterloo St to Main St, causing a traffic delay
Driver of a vehicle in through lane from Waterloo St to Main St stops in the travel lane between Ashby St and Main St and appears to be yelling at or talking to either another driver or a member of one of the groups. Unable Gabriel Cardino used an air horn to attempt to interfere with the regular Vigil activity, and then used an athletic whistle. At approximately 11 a.m. he crossed the street to the BLM side and began blowing the whistle loudly and yelling "time to go!" in an attempt to disrupt a meeting the BLM group was having. This distracted drivers and many vehicles slowed down as they passed. One vehicle stopped completely in the travel lane for 12
Driver of a full-size red pickup truck turns left from Main St. onto Alexandria Pike then stops in the crosswalk to complain to the police officer about the compressed air horn used by Gabriel Cardino.
Man comes from area where BLM is meeting, walks part way across Alexandria Pike crosswalk, walks diagonally across Main St./Alex. Pike intersection while traffic is driving around him, and walks up to ALM area. Man stands Scott Christian reported that Gabriel Cardino began yelling across the street at BLM members starting at 10:45 a.m., then walked over to their side at 11 am and threatened 3 people. Mr. Christian said Jon Trevathan was one of those people and will be filing "charges with the court". Protective Order was later issued for Cardino to stay Jennifer Ragle was standing on Alexandria Pike to the north of the entrance of Miller Carpet with a tripod set up. The tripod and her positioning meant there was not an ADA compliant width available for wheelchairs. Some ALM member standing at the curb in front of G.D. Court with a sign leaning up against their leg, steps out into the street without looking when the sign falls into the street.
Multiple vehicles traveling west on Main Street in front of the General District Court drive through the eastbound turn lane from Main Street onto Alexandria Pike. Related to how close the BLM group members are standing to the curb? Most are standing far enough back from the curb to allow for pedestrian & ADA ingress Two vehicles with impatient drivers turn left from eastbound turn lane on Main Street onto Alexandria Pike, with other vehicles waiting on Alexandria Pike that had the right of way.
White diesel pickup truck on Alexandria Pike pulled up to Main Street, driver waived toward ALM group, then "rolled coal" while making a right onto Main Street as it was driving past the BLM group
Black/gray pickup truck on Alexandria Pike pulled up to Main Street, honked horn/waived at ALM group, then Two vehicles, one turning left from Alexandria Pike to Main Street, and one turning left from Main Street (eastbound) onto Alexandria Pike, nearing collided in the intersection. It appeared the driver of the eastbound A vehicle traveling north on Alexandria Pike to turn left onto Main Street apparently did not see a vehicle heading east on Main Street (passing in front of General District Court), and was waving at and looking in the Chief Carter observed occupants of two different vehicles drive by the BLM group and display their middle finger Decision made to move BLM and counterdemonstration groups to Eva Walker Park.
