

**AMENDMENT TO MARCH 11, 2024 CONTRACT FOR SERVICES BETWEEN  
WAUCHULA COMMUNITY REDEVELOPMENT AGENCY AND KRAUSE GROVE  
SERVICE, INC.**

This Amendment to the March 11, 2024, Contract for Services is made and entered into this \_\_\_\_\_ day of March, 2026, by and between the Wauchula Community Redevelopment Agency (the "CRA"), and Krause Grove Service, Inc., d/b/a Krause Services ("Vendor"), collectively referred to as the "Parties"

**RECITALS**

**A.** The CRA and the Vendor entered into that Contract for Services (the "Agreement"), dated March 11, 2024, to provide for lawn care and landscaping services.

**B.** The Agreement is reaching the end of its term and the Parties desire to extend the Agreement for one, six-month extension.

**C.** The Parties have therefore agreed, pursuant to Section 20.0, Modification, of the Agreement, to modify Section 1.0, Term, to provide for one, six-month extension of the Agreement.

**ACCORDINGLY**, in exchange for good and sufficient consideration, the sufficiency of which is acknowledged by the parties, the parties hereby agree as follows:

**SECTION 1. RECITALS.** The above recitals are true and correct, and form a material part of this Amendment.

**SECTION 2. AMENDMENT TO AGREEMENT.** Section 1.0, Term, of the Agreement is hereby modified as follows:

1.3 The Parties agree to extend the term of the Agreement to and including September 30, 2026, at which time the Term of the Agreement will expire and the Agreement will automatically terminate. ~~CRA shall have the option of extending the Agreement as deemed reasonable and necessary for up to three (3) terms of one (1) year each.~~

1.4 ~~The CRA Board will approve and execute each extension or terminate the agreement at the end of any given term.~~

**SECTION 3. EFFECT OF THIS AMENDMENT.** Except as expressly modified by this Amendment, the terms of the Agreement shall remain unchanged, and are hereby ratified and confirmed.
