| SUMMARY and/or JUSTIFICATION: | | <p>Group/Seat 3 was previously held by Mayor O'Connor and as a result of the March 2022 election cycle, the seat became vacant March 14th.</p> <p>By Charter, if any vacancy occurs in the office of any councilmember and the remainder of the unexpired term is less than 2 years and 81 days, the remaining councilmembers shall, within 30 days following the occurrence of such vacancy, by majority vote, appoint a person to fill the vacancy for the remainder of the unexpired term.</p> <p>A call for those interested in serving on the Council was published From March 15th through April 5th. Thereafter a Council discussion on the vacancy was held at the April 11th Council Meeting in which the item was tabled. Further a workshop meeting was held April 19 interviewing interested candidates.</p> | | |
