SUMMARY and/or JUSTIFICATION:	Annual engagement of services to audit the financial statements for the City of Westlake, which are comprised of governmental activities and each major fund as of, and for the year ended September 30, 2025.  Fees for services are based upon the value of the services performed and the time required by the individuals assigned to the engagement, plus direct expenses. Invoices for fees will be submitted in sufficient detail to demonstrate compliance with the terms of engagement and shall not exceed \$12,750.00, unless the scope of engagement is changed, the assistance which of City of Westlake has agreed to furnish is not provided, or unexpected conditions are encountered.  There is an increase of \$5,000 outside of the normal 5% increase to reflect the additional time and resources necessary to complete the FY25 engagements. Over the past few years, the level of effort involved in these audits has grown significantly, and the prior fees no longer cover the time required to complete the work effectively.
