ORDINANCE NO. 2024-03

AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA, AMENDING THE CODE OF ORDINANCES BY SPECIFICALLY AMENDING CHAPTER 8 ENTITLED "PARKING

REGULATIONS" BY SPECIFICALLY AMENDING SECTION 7 ENTITLED "RECREATIONAL VEHICLES, TRAILERS AND WATERCRAFT"; PROVIDING FOR DEFINITION OF TRAILERS; PROVIDING FOR PROHIBITION OF PARKING ON RIGHTS OF WAY; PROVIDING FOR THE DELETION OF ARTICLE 8.9 (E) RELATIVE TO ELECTRIC VEHICLE CHARGING STATIONS; PROVIDING FOR THE AMENDMENT TO TABLE 8-6 ENTITLED "REQUIRED OFF-STREET PARKING SPACES"; PROVIDING FOR CODIFICATION, PROVIDING FOR A CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.

Mayor O'Connor introduced the item.

Mr. Swartz read the Resolution, by title only, into the record.

Mayor O'Connor asked for presentations.

The City Manager stated there were no word changes, but in the final draft the first section, applicability, should have been identified as red-lined.

Mr. Leon gave clarity to the changes added on September 3, 2024, based on Council requests.

Mayor O'Connor asked about the definition of swamp buggy and pull trailer.

Mr. Leon explained that the definitions are listed in the Code. Mr. Cassel further explained that when the Code was written, all definitions were put in one place to better help when changes were needed in the future. This means changes would be in that one section versus finding the definition throughout the entire Code.

Mayor O'Connor called for public comments.

<u>Kathryn Rossmell - Minto PBLH, LLC –360 S Rosemary Ave, Ste 1100</u> – Ms. Rossmell asked to be sworn in with legal to speak on the second reading.

Mr.. Swartz wore in Ms. Rossmell.

Ms. Rossmell thanked the City Manager for bringing more attention to Section One - Applicability language. She requested that when it is approved, it is made clear that the approval is with the applicability section being added as new language and requested permission that a copy of the Ordinance with that formatting be filed so there is no confusion moving forward.

Mayor O'Connor confirmed approval of Ms. Rossmell adding a copy of the Ordinance for the record.
