Public Comment – Ms. Stormi Bivin – 16100 Key Biscayne Lane - Ms. Bivin addressed the council regarding a Blue Star memorial marker for the future civic park. She had previously presented this idea with another Wellington Garden Club member in November and wanted an update on the timing of the park. She noted that the Garden Club had funded this project in their 2025-26 budget.

Public Comment – Donna Peters – 3986 Whippoorwill Circle - Ms. Peters She asked about plans for pickleball courts and tennis courts that realtors had mentioned, the status of Lowe's construction, and whether a Walmart would be built in the area.

Public Comment – Mr. Bobby Farber – 4829 Saint Armands Way - Mr. Farber requested the council amend Ordinance 2021-12, article 24.2, section 7a, to require that all public art include a placard with the artist's name, concept description, and construction information. He also provided an update on his coordination with FPL to assess and replace streetlights. Lastly, he mentioned a new community group forming in Westlake that might request space in the future park.

PUBLIC HEARING - QUASI JUDICIAL

- A. MSP-2025-02:** The applicant, Coteleur & Hearing on behalf of Palm Beach West Associates VI, LLLP (A/K/A GL Homes), is requesting approval of a Master Sign Plan for the Silver Lake residential development. The request includes an alternate design for Residential Pod Entry Monument signs and proposes two (2) mirrored signs at the sole entrance along Persimmon Blvd. East. The application includes two (2) waivers from the City's sign code, specifically requesting to allow two (2) entry monument signs and to permit a reduced setback of fifteen (15) feet from the nearest property line.

Mayor O'Connor introduced the item and asked the City Attorney to swear in the witnesses.

Mr. Doody swore in witnesses who would provide testimony. Council members disclosed ex parte communications, with all members noting they had met with the applicant and planner to discuss the item.

Mr. Cleves, Planner for the City of Westlake, presented the application details, explaining that the Silver Lake residential development was located south of Persimmon Boulevard.

Mr. Donaldson Hearing, representing GL Homes, presented the request for a master sign plan approval for an alternative pod entry monument sign. He explained the signs would be located at the entrance on Persimmon. Mr. Hearing also showcased the proposed design, which incorporated a glass tile totem mimicking the standard pod entry monument signs and included a water wall feature. He noted that water features were common in GL Homes developments.

Public Comment – Mr. Bobby Farber – 4829 Saint Armands Way - Mr. Farber suggested adding plexiglass in front of the water feature to prevent children from climbing in, particularly given the nearby school.

Public Comment – Alicia Torres – 5447 Whippoorwill Circle - Ms. Torres asked for clarification about the 15-foot setback versus the required 80-foot setback mentioned during the presentation.

Public Comment – Mr. Bobby Farber – 4829 Saint Armands Way - Mr. Farber asked if there would be a possibility of a road expansion on Persimmon Blvd.

B. MSP-2025-04: The applicant is requesting a Master Sign Plan approval for the project known as, "Tractor Supply" located in Parcel F2 within the Westlake Landings development. The application also includes one (1) waiver request.

Mr. Cleves, Planner for the City of Westlake, presented the application, where the applicant is requesting Master Sign Plan approval for two signs: one wall sign on the principal building and one wall sign on the adjacent garden life center structure. The application included one waiver request to allow a cabinet sign for the logo.

Detailed Council discussion regarding the specific design of the sign.

Discussion by Tractor Supply's sign manufacturer explaining their typical sign package.

Additional council discussion determined that the applicant could either comply with the channel letter requirement or submit documentation showing the logo qualified as a federally registered trademark, which would potentially allow for the cabinet sign under existing code.

Mr. Leon, Planner for the City of Westlake, presented the second reading of Ordinance 2025-04, noting that it had been approved by the LPA and Council on first reading on June 3, 2025, with no changes since the first reading. The ordinance amends Chapter 119 to provide clarification regarding screening exceptions for single-family residential lots.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WESTLAKE, FLORIDA, AMENDING CHAPTER 119, "ZONING," OF THE CITY'S CODE OF ORDINANCES; SPECIFICALLY AMENDING SECTION 119-31, "RESIDENTIAL DISTRICTS," UNDER ARTICLE II, "ZONING DISTRICTS AND STANDARDS," TO ESTABLISH DEVELOPMENT STANDARDS FOR COTTAGE HOMES WITHIN THE R-1 AND R-2 ZONING DISTRICTS AND TO ALLOW REDUCED SIDE YARD SETBACKS FOR CERTAIN SINGLE-FAMILY ATTACHED UNITS; AMENDING CHAPTER 101, "GENERAL AND ADMINISTRATIVE PROVISIONS," UNDER ARTICLE I, SECTION 101-1, "DEFINITIONS AND ACRONYMS," TO INCLUDE DEFINITIONS RELATED TO COTTAGE HOMES; AMENDING CHAPTER 117, "SUBDIVISION AND SITE DEVELOPMENT STANDARDS," UNDER ARTICLE VII, SECTION 117-176, "MINIMUM STANDARDS; ACCESS AND CIRCULATION SYSTEMS," TO ESTABLISH STANDARDS FOR COMMON DRIVEWAY ACCESS; PROVIDING FOR CODIFICATION, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

Mayor O'Connor introduced the item and Mr. Doody read Ordinance 2025-06 in to record, by title only.

Mayor O'Connor called for any staff comments or presentations.

Mr. Leon presented this text amendment that had been approved by the Local Planning Agency. The proposal would add definitions for "cottage home" to Chapter 101, amend Chapter 117 for access and circulation systems, and amend tables in Chapter 119 to incorporate development regulations for cottage homes.

Mr. Hearing, representing Minto PBLH LLC, explained that the purpose of the amendment was to facilitate Minto's desire to introduce additional products into the community. He described two new housing types: paired villas (two attached single-family units) and cottage homes (also two attached units but accessed from a private access easement rather than an alleyway).

CITY COUNCIL COMMENTS

- A. Councilwoman Leonard wished everyone a happy Fourth of July.
- B. Councilman Gleason wished everyone a happy Fourth of July and suggested adding a reminder at the beginning of meetings for visitors to silence their cell phones.
- C. Councilman Werner wished everyone a happy Fourth, reminded everyone about the upcoming Fourth Fest event, and thanked the council for their work on the strategic planning workshop.
- D. Vice Mayor Langowski wished everyone a happy Fourth and encouraged attendance at the Fourth Fest event.
- E. Mayor O'Connor echoed his colleagues' Fourth of July wishes and encouraged attendance at Fourth Fest, noting new, exciting elements this year. He expressed disappointment about the governor's veto of the park appropriation but assured everyone that the city was pursuing alternative funding avenues and had a call scheduled with the governor's office after the Fourth of July.

REPORT – STAFF

PBSO provided their monthly update.

REPORT - CITY ATTORNEY

Mr. Doody reported that there had been a hearing the previous day on a lawsuit brought by a resident addressing the selection process. He noted that the court had taken the matter under advisement and had not yet issued a ruling.

REPORT - CITY MANAGER

Mr. Cassel provided an update on the HAPPY program, reporting that from January 1 to June 30, 2025, they had made 22 awards with seven more awards executed that day. He noted that the modifications made to the program were helping distribute more funds to heroes and others.

Mr. Cassel also alerted the council and the public about the upcoming railroad crossing rebuild on Northlake Blvd. that would close the road completely for eight days, tentatively scheduled for around July 25. He explained that PBSO, DOT, and fire departments were coordinating a traffic management plan with signage and monitoring but warned that rush hour traffic would be significantly impacted.

PUBLIC COMMENTS

Public Comment – Alicia Torres – 5447 Whippoorwill Circle - Ms. Torres expressed disappointment about the park funding veto and asked about the status of the grass seeding at the site. She also inquired about the sheriff's office plans to be next to the fire station. Ms. Torres inquired about the upcoming 2026 elections.
