This increase was not reflected in the FY22 budget adopted in September, resulting in the property tax revenue being lower in the budget than what the City will actually receive in FY22. The Florida Department of Revenue requires that the City readvertise the Notice of Tax Increase and Budget Summary for another budget hearing and re-adopt the FY22 Millage Rate and Budget. ## **RESOLUTION 2021-35**

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA, RE-ADOPTING, IN COMPLIANCE WITH SECTION 200.065(13), F.S., THE FINAL AD VALOREM MILLAGE RATE TO BE LEVIED FOR THE FISCAL YEAR BEGINNING ON OCTOBER 1, 2021, AND ENDING ON SEPTEMBER 30, 2022; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on November 9, 2021, the City received a notice from the Florida Department of Revenue advising the City that the City's previous Notice of Proposed Tax Increase was incorrect under Section 200.065(2)(a)1, F.S.; and

WHEREAS, pursuant to applicable provisions of law, the City of Westlake has computed a final millage rate and prepared a final budget in compliance with Section 200.065(13) for the fiscal year beginning October 1, 2021 and ending on September 30, 2022; and

WHEREAS, a "Notice of Final Millage Rate and Final Budget Hearings" re-advertising and advising the public that a public hearing on the final millage rate and final budget would be held on November 22, 2021, has been advertised as required by Florida Statute 200.065(13); and

WHEREAS, said public hearing has been held as stated above and comments from the public concerning said final millage rate and final budget have been heard and considered; and

WHEREAS, the gross taxable value for operation purposed not exempt from taxation within Palm Beach County, has been certified by the Palm Beach County Appraiser to the City of Westlake as \$358,749,646; and

WHEREAS, it is the desire of the City Council for the City of Westlake to adopt a final millage rate for the fiscal year beginning October 1, 2021 and ending on September 30, 2022;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA:

- SECTION 1. The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Council. All exhibits attached hereto are hereby incorporated herein.
- SECTION 2: That the final ad valorem millage rate of \$1,000.00 of assessed value for real and personal property value as established by the Palm Beach County Property
