## **ORDINANCE 2025-01** 1 2 3 AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE 4 CITY OF WESTLAKE, FLORIDA; PROVIDING FOR THE REPEAL OF 5 CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A 6 PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE 7 MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN 8 SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE. 9 10 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTLAKE, FLORIDA: 11 12 13 Section 1: The Code entitled "Code of Ordinances of the City of Westlake, Florida," published 14 by CivicPlus, LLC, consisting of chapters 1 through 119, each inclusive, is adopted. 15 16 Section 2: All ordinances of a general and permanent nature enacted on or before April 2, 2024, and not included in the Code or recognized and continued in force by 17 reference therein, are repealed. 18 19 20 Section 3: The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is 21 22 repealed by this ordinance. 2.3 24 Section 4: Unless another penalty is expressly provided, every person convicted of a violation of any provision of the Code or any ordinance, rule or regulation adopted or issued 25 26 in pursuance thereof shall be punished by a fine not exceeding \$500.00, a definite term of imprisonment not to exceed 60 days, or any combination thereof. Except as 27 28 otherwise provided by law or ordinance: (i) With respect to violations of this Code 29 that are continuous with respect to time, each day that the violation continues is a 30 separate offense; and (ii) With respect to violations that are not continuous with respect to time, each act constitutes a separate offense. The penalty provided by this 31 32 section, unless another penalty is expressly provided, shall apply to the amendment 33 of any Code section, whether or not such penalty is reenacted in the amendatory 34 ordinance. In addition to the penalty prescribed above, the city may pursue other 35 remedies such as abatement of nuisances, injunctive relief and revocation of licenses or permits. 36 37

Additions or amendments to the Code when passed in such form as to indicate the intention of the city to make the same a part of the Code shall be deemed to be

incorporated in the Code, so that reference to the Code includes the additions and
