AN ORDINANCE TO REAFFIRM THE NECESSARY FINANCIAL COMMITMENT OF THE CITY OF WEST MONROE, LOUISIANA RELATING TO THE PROJECT “WEST MONROE STORMWATER MITIGATION PROJECT”, DISASTER/AWARD # LPDM-PJ-06-LA-2023-002; TO FURTHER AUTHORIZE THE MAYOR TO PROVIDE ANY AND ALL FURTHER CERTIFICATION AS MAY BE REQUESTED, AND OTHERWISE FULFILL THE OBLIGATIONS OF THE CITY OF WEST MONROE, LOUISIANA AS IT RELATES TO THIS PROJECT; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

SECTION 1. BE IT ORDAINED by the Mayor and Board of Alderman of the City of West Monroe, Louisiana, in regular and legal session convened, that the City of West Monroe, Louisiana, hereby reaffirms its match commitment of \$1,613,659, which is 40% of the total project cost of \$4,013,659, relating to the Project "West Monroe Stormwater Mitigation Project", Disaster/award # LPDM-PJ-06-LA-2023-002, which commitment is from unencumbered funds which are available from the Capital Fund account of the City of West Monroe, which receives an average monthly deposit of \$550,000 from sales tax revenue

SECTION 2. BE IT FURTHER ORDAINED by the Mayor and Board of Alderman of the City of West Monroe, Louisiana, in regular and legal session convened, that Staci Albritton Mitchell, Mayor of the City of West Monroe, Louisiana, is hereby further authorized to execute any and all documents, authorizations or commitments, including but not limited to that letter for commitment of match funds attached as “Exhibit A”, and to undertake any and all actions which are necessary, appropriate or desirable in order to certify to this commitment by the City of West Monroe, or to meet any and all other requirements relating to the award of that project, or otherwise to fulfill the obligations of the City of West Monroe, Louisiana, as it relates to the funding.
