AN ORDINANCE TO AUTHORIZE THE MAYOR OF THE CITY OF WEST MONROE, LOUISIANA, TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH DAVID LANE BEAIRD & ASSOCIATES, INC. FOR CERTAIN ENGINEERING, SURVEYING AND RELATED SERVICES IN CONNECTION WITH THE PROJECT KNOWN AS “WEST MONROE RIVERFRONT PARK FISHING PIER PROJECT”; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

SECTION 1. BE IT ORDAINED by the Mayor and Board of Aldermen of the City of West Monroe, Louisiana, in regular and legal session convened, that Staci Albritton Mitchell, as Mayor of the City of West Monroe, Louisiana, be and she is hereby authorized to execute on behalf of the City of West Monroe, Louisiana, a Contract For Engineering, Surveying, and Related Services with David Lane Beaird & Associates, Inc. for certain engineering, surveying and related services on the project known as “West Monroe Riverfront Park Fishing Pier Project”, the suggested provisions of which contract are attached as Exhibit “A” (various parts).

SECTION 2. BE IT FURTHER ORDAINED by the Mayor and Board of Aldermen of the City of West Monroe, Louisiana, in regular and legal session convened, that Staci Albritton Mitchell, as Mayor of the City of West Monroe, Louisiana, be and she is hereby further authorized to further discuss and/or negotiate the terms and provisions of the engagement and make any appropriate changes in the proposed contract, and thereafter to execute that revised contract to take any and all actions and to execute any and all further documents she deems either necessary or proper to negotiate, prepare, execute and carry out the activities arising out of the contract described above according to its terms and intent, including but not limited to such negotiations and modifications as she determines appropriate regarding the terms and conditions of the employment, the nature of the services performed and the manner of calculation of compensation for those services.
