AN ORDINANCE TO CORRECT A TYPOGRAPHICAL ERROR IN ORDINANCE NO. 5064, AND TO AUTHORIZE THE EXECUTION OF A GRANT FROM THE LOUISIANA DEPARTMENT OF ADMINISTRATION, OFFICE OF COMMUNITY DEVELOPMENT LOCAL GOVERNMENT ASSISTANCE PROGRAM (LGAP) FOR A 2021-2022 FISCAL YEAR GRANT RELATING TO THE SANITARY SEWER FORCE MAIN REPAIRS PROJECT, NOW REFERRED TO AS "S 11TH STREET SANITARY SEWER FORCE MAIN IMPROVEMENTS PROJECT"; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, in Ordinance No. 5064, adopted on May 10, 2022, the Mayor was authorized to apply for a \$50,000.00 grant from the Louisiana Department of Administration, Office of Community Development, Local Government Assistance Program (LGAP) for fiscal year 2022 - 2023 relating to the Sanitary Sewer Force Main Project; and

WHEREAS, when the City was approved for an amount of \$46,050.00, a typographical error was discovered in Ordinance No. 5064, in that it referred to the Fiscal Year 2022-2023 program when, in fact, the application was intended for the Fiscal Year 2021-2022 program; and

WHEREAS, in order to avoid future confusion this typographical error should be noted and corrected while accepting the grant award and approving execution of the grant contract, and that corrected designation should now be used for future clarity; and

WHEREAS, the focus of the proposed project has been narrowed, and the more specific name of the project, "S 11th Street Sanitary Sewer Force Main Improvements" now also be used for future clarity.

NOW, THEREFORE,

SECTION 1. BE IT ORDAINED by the Mayor and Board of Alderman of the City of West Monroe, Louisiana, in regular and legal session convened, that all references to Fiscal Year 2022-2023 in Ordinance No. 5064 are acknowledged as typographical errors, and it is hereby amended to correctly refer to Fiscal Year 2021-2022 throughout, with the more specific designation of "S 11<sup>th</sup> Street Sanitary Sewer Force Main Improvements" to now be used as the official project name.

SECTION 2. BE IT FURTHER ORDAINED by the Mayor and Board of Alderman of the City of West Monroe, Louisiana, in regular and legal session convened, that Staci Albritton Mitchell, as Mayor of the City of West Monroe, Louisiana, be and she is hereby authorized to execute that grant agreement from the Louisiana Department of Administration, Office of Community

Development, Local Government Assistance Program (LGAP) for Fiscal Year 2021-2022 relating to the "S 11<sup>th</sup> Street Sanitary Sewer Force Main Improvements" project, in the amount of \$46,050.00, all according to the provisions of that grant contract between the Division of Administration and the City of West Monroe, a copy of which is attached as Exhibit "A".

SECTION 3. BE IT FURTHER ORDAINED by the Mayor and Board of Alderman of the City of West Monroe, Louisiana, in regular and legal session convened, that Staci Albritton Mitchell, as Mayor of the City of West Monroe, Louisiana, be and she is hereby further authorized to execute any and all further documents or agreements relating to the grant awarded and its provisions, together with any and all further documents which are either necessary or desirable in order to fulfill the requirements of the grant.
