- 4. Lower new manhole top in front of Tillman Tire down to grade. (\$1,000)
- 5. Replace sewer sentry in manhole 22-0800 top. (\$150)
- 6. Install Sure Seal cleanout on the Bayou Overhead Door service main. (\$400)
- 7. Check every service connection and provide Sure Seal cleanout if missing. (\$750)
- 8. Grout around all sewer mains entering new sewer manhole #5. (\$500)
- 9. Sewer service at 145' in post tv video MH22-0800 to MH22-0795 has settled and needs to be realigned. (\$800)
- 10. Sewer service at 12' in post tv video MH5 to MH22-0690 has settled and needs to be realigned. (\$800)
- 11. Install 70-LF of 8" HDPE pipe bursting under Copley Street and install one new manhole at bid price. (\$10,383.20)
- 12. Install catch basin at North 3rd and Travis Street intersection. (\$5,968.50)
- 13. Install 163-LF of CIPP liner and reinstate service between new manhole at Copley and MH22-0850. (\$21,925.90)
- 14. Liner at manhole 22-0710 ring to be inspected at 1-year.
- 15. Bucket lid in new sewer manhole #3 to be removed.
