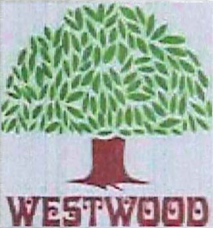

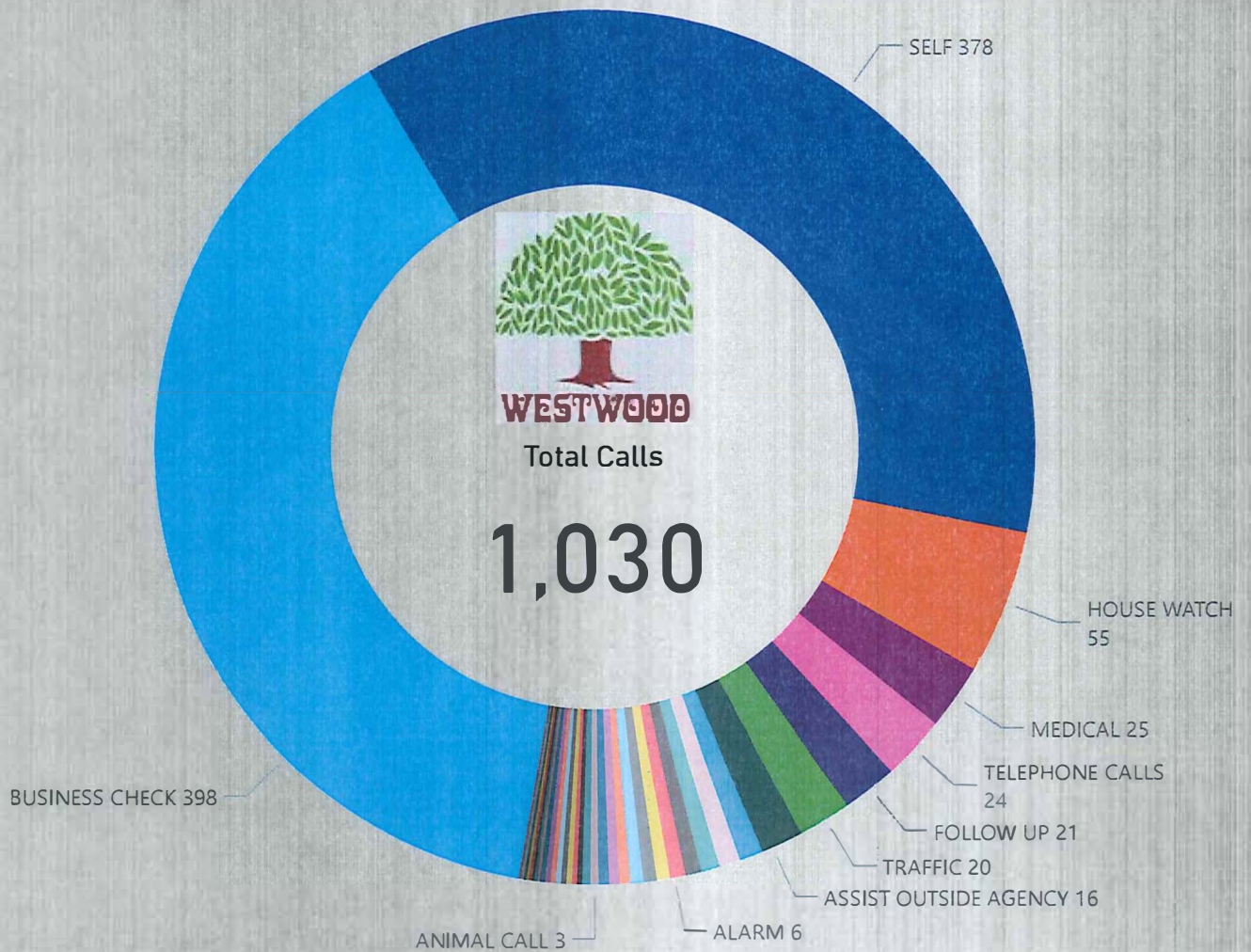

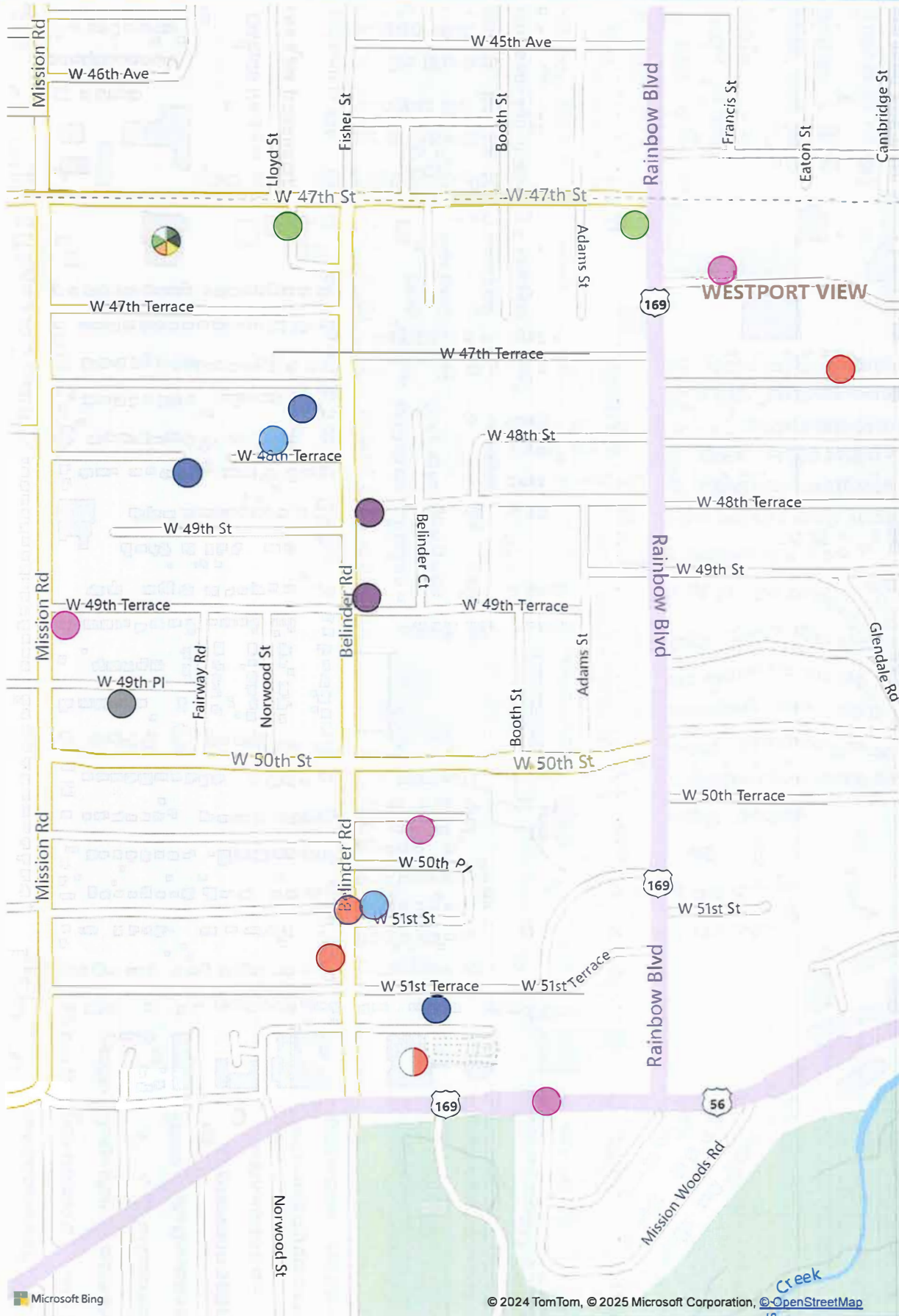

Case Number	Nature of Call	Summary
20240458	THEFT REPORT	Reporting officer responded for a theft of articles of clothing. No suspect information was available.
20240459	TRAFFIC	Subject was stopped for a traffic violation. Upon doing a records check it was revealed that he had an outstanding warrant from Leawood. Leawood Police Officer showed up to the traffic stop and took custody of the subject.
20240460	TRESPASSING	Reporting officer responded for a trespassing call. Subject had been previously trespassed from there and was cited then released.
20240461	TRAFFIC	Reporting officer stopped a vehicle for expired tags. The driver had a felony warrant out of KCMO. Transported to Olathe ADC.
20240463	FOLLOW UP	Reporting officer was notified by Homeland Security to take an initial report for a resident who was a victim of fraud.
20240466	WARRANT SERVICE	Subject was contacted by Prairie Village Police Department during a traffic stop and she showed to have a Westwood warrant for FTA on traffic charges. I responded to the scene and she paid the fine and was released.

20240470	CHECK THE WELFARE	Reporting officer found narcotics in vehicle while responding to a call. Subject was transported to hospital. Sending charges to the Johnson County DA.

20240489	TELEPHONE CALLS	Reporting officer was dispatched to suspicious activity and recovered property.
20240490	ASSAULT REPORT	Reporting officer spoke to victim who had a handgun pointed at them in a parking lot stemming from a road rage incident that started in KCK. Suspect and vehicle description was obtained.
20240491	THEFT REPORT	Reporting officer responded for a previous theft. Four females pushed a cart full of items passed all points of sale. The suspects left the parking lot in a white Jeep Cherokee.

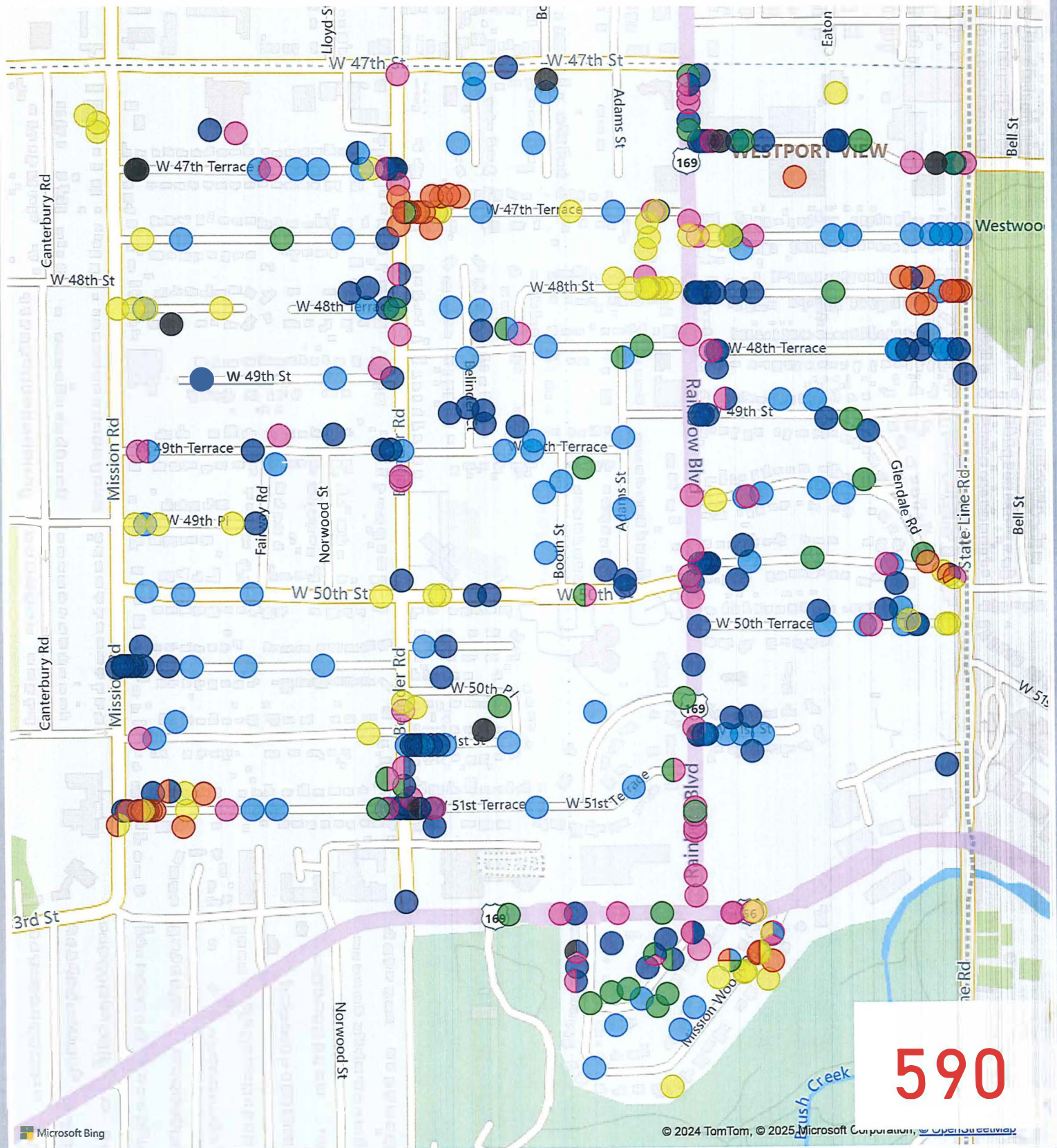
