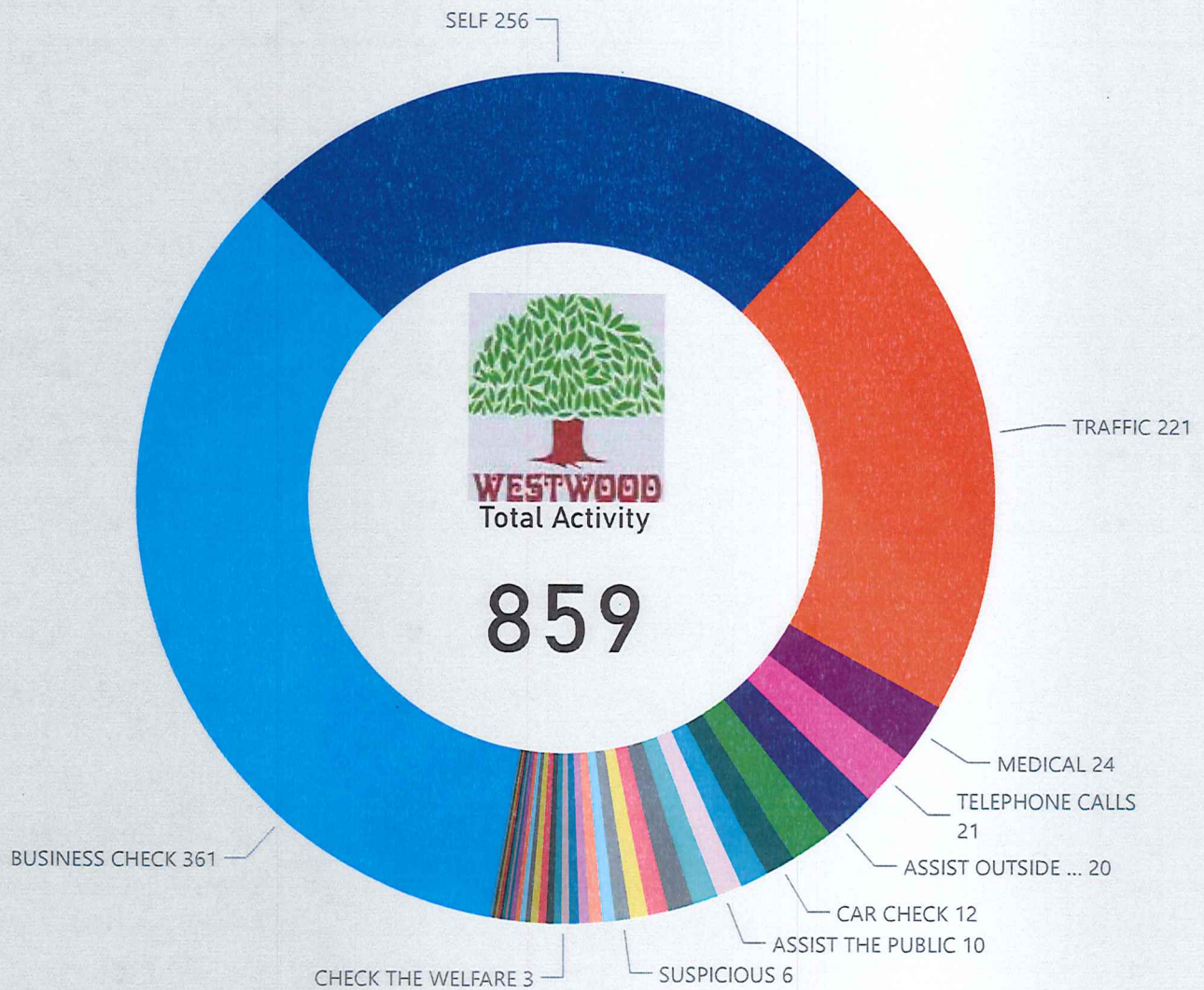

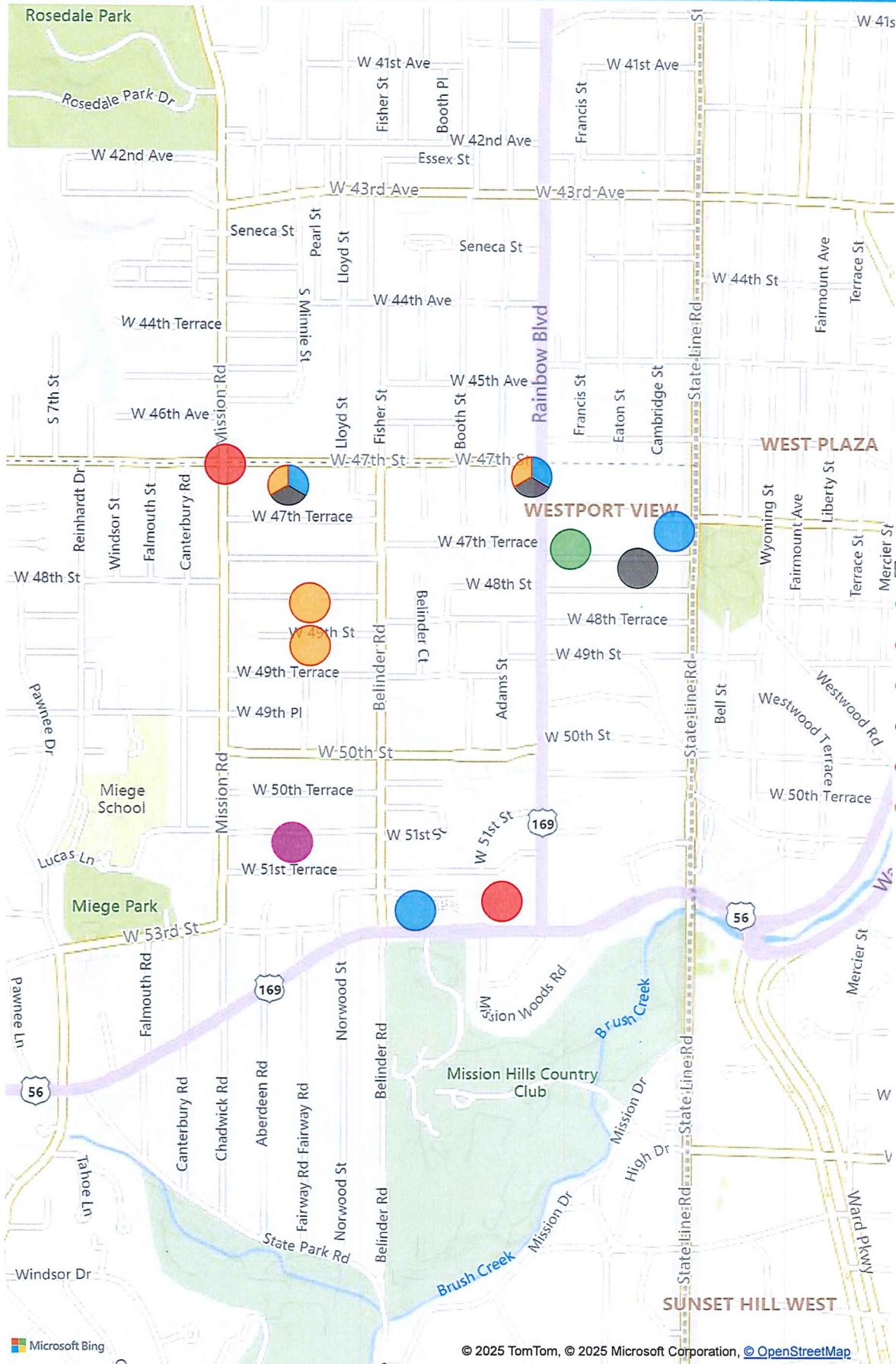

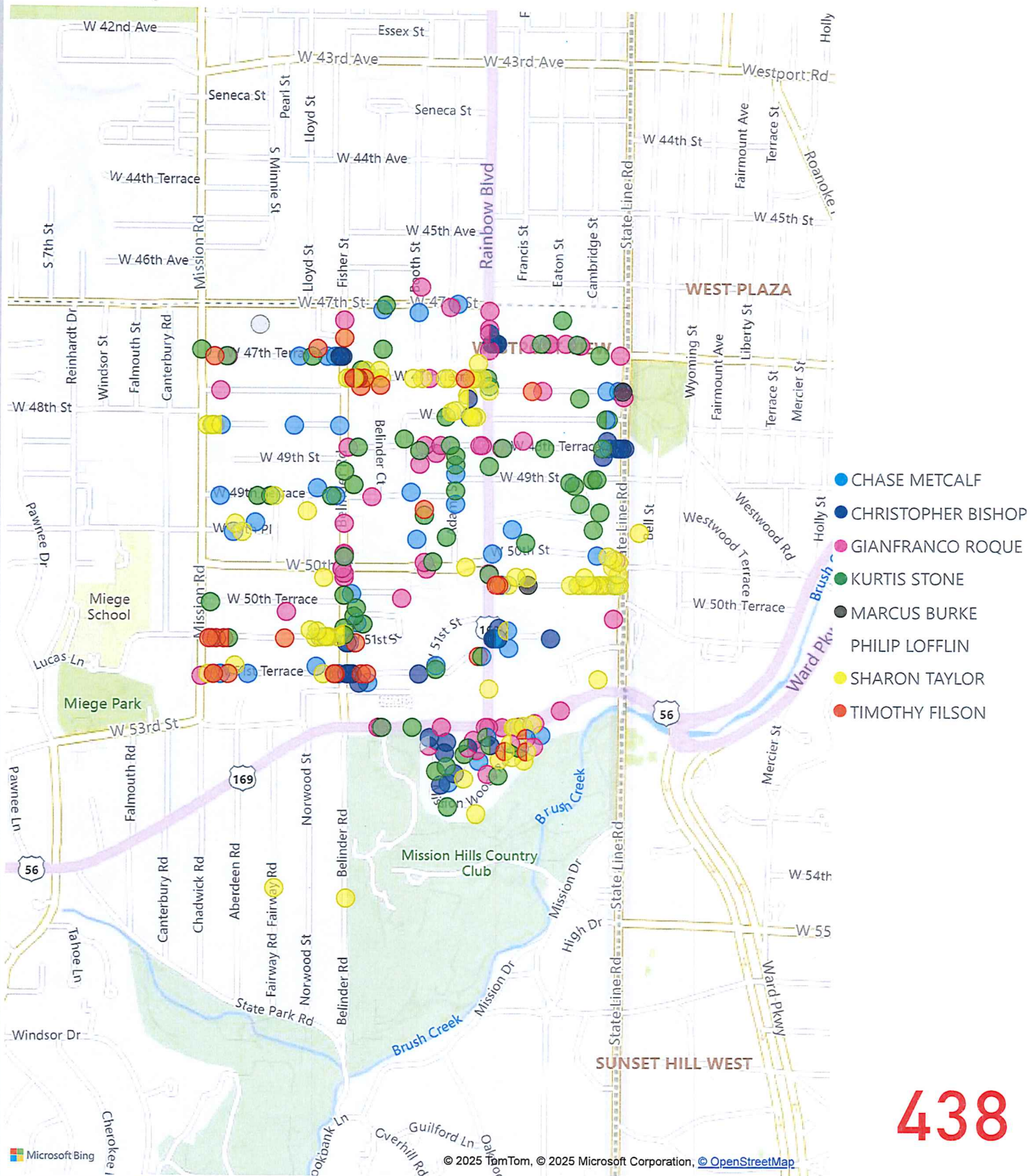

Case Number	Report Type	Summary
20250203	Theft	Reporting officer responded to a theft in progress at Walmart. Officer observed offender leave through the entrance doors and arrested him.
20250206	Warrant	A subject responded to the station and posted cash bond on his Westwood warrant for FTA on traffic.
20250207	Theft	Officers responded to the police station for a reported theft of a lost wallet. The subject believed the wallet to have been stolen at Walmart.
20250208	Theft	Reporting officer responded to a stolen KS tag that occurred between April and June.
20250209	Warrant	Officer confirmed a Westwood warrant for the jail. Officer faxed the warrant to the jail to be served.
20250212	Warrant	Olathe arrested and booked a subject on three Westwood warrants, which were faxed to the jail to be served.
20250217	Alcohol violations	Traffic stop for a lighting violation. Right front passenger was in possession of an open container of alcohol.
20250218	General Information	Reporting officer responded to the 2000 blk W. 47th Ter. for an unknown disturbance between a resident and a demolition crew.
20250219	Warrant	Officer confirmed a warrant then faxed it to the jail to be served.
20250220	General Information	Reporting party called from Pittsburg, concerned that something inappropriate was going on with her six-year-old son while visiting with his father in Westwood. She requested a welfare check and no signs of criminal activity was determined to have occurred.
20250221	Warrant	Reporting officer faxed a Westwood warrant to Olathe ADC to be served to a subject.
20250222	General Information	Officer was dispatched to a vehicle fire at Woodside Gym. The engine compartment was fully engulfed in fire. Engine 22 arrived on scene and extinguished the fire with water. The vehicle was towed to a location at the discretion of the owner.
20250223	Warrant	Officer responded to a walk in warrant arrest. Subject posted bond and was given a new court date.
20250227	General Information	Listed subject wanted to report a lost/missing/stolen USA passport and unknown amount of cash.
20250229	Warrant	Subject was contacted from a disturbance call at Wal-Mart. Upon doing a records check it was determined that he had an outstanding Douglas County warrant. I placed the subject under arrest and transported him to Olathe ADC.

20250231	Warrant	Reporting officer responded to the station to confirm Westwood warrant 20240157. Johnson County Sheriffs deputy had the subject stopped on traffic. The warrant was confirmed and faxed to Olathe ADC. Subject was transported by Johnson County Sheriffs office.
20250232	Drugs/Narcotics	Officers stopped a car for a traffic violation, and the uncooperative juvenile driver was concealing marijuana in his pants and his car. The juvenile offender was provided court information and released to a parent.
