5.1 Consideration and Adoption of Resolution Amending the Fiscal Year 2024-25 General Fund Budget to Account for the Receipt and Expenditure of California Intergovernmental Risk Authority Grant Funding

City Manager B. Zenoni presented the staff report for consideration and adoption of resolution amending the Fiscal Year 2024-25 General Fund Budget to account for the receipt and expenditure of California Intergovernmental Risk Authority (CIRA) Grant Funding. Zenoni explained that grant funding is available from CIRA to fund repairs to the restroom at C Street Park. The public restrooms were in need of major repairs at an estimated cost of approximately \$22,000 and these grant funds would cover the entire cost, with no cost to the City.

**Finance Director Mahoney** reported that completion of the annual financial audit had been delayed due the death in the family of the auditor, and it is anticipated that the audit will be presented to the City Council in February.

**City Manager Zenoni** reported on the status of the Corporation Yard repairs and advised the City Council he anticipated presenting a status on the Regional Sewer Project at the January 28th City Council meeting.
