NEW BUSINESS

A. Update on TIF Plan Opt-Out Status

The White Lake Library had officially opted out of the TIF Plan. Several staff had met with Oakland County, and met additionally with Oakland County's TIF sub-committee. The sub-committee opted out as well and was putting together their own agreement to negotiate with the Township. The hope was for the agreement to be ready to review in March. OCC and Huron Clinton Metro Authority did not opt out, so their funds would be captured.

Supervisor Kowall said it was disheartening that there were members of the sub-committee at the County who did not know what the Township was doing. He was distressed by the lack of knowledge and understanding from the sub-committee.

RCOC granted the permit to rebuild Elizabeth Lake Road. There would be a contribution from the County to the Township to cover \$200,000.00 of engineering costs. Bids for the project would be due February 7th. There was a bid opening for Triangle Trail and Stanley Park. The Parks fund did not have the funds to cover both projects, so a possible option to bond was being considered. The Parks and Rec millage was considering language as the previous millage expired December 31, 2023. Renewal was would be .3%, or a new millage at .5%.
