A. <u>Stanley Park Phase 1: Update</u>

Director O'Neil presented drone photos of the construction progress at Stanley Park. Paving and restoration are scheduled to be completed next week. The exercise station is backordered and will not be delivered until the end of the month. If the station comes in late, it will have to be installed in April 2026 due to protection of the wildlife. A punchlist will be established shortly.

# B. <u>Stanley Park Phase 2 - Grant Application: Update</u>

Director O'Neil stated the preliminary score for the Phase 2 grant came back; the application scored decently, and Beckett and Raeder believed another 30-40 points could be scored with application revisions. The application resubmittal made it in before the October deadline, and final results will be revealed in December.

Director O'Neil said maintenance of the parks will be refocused going forward. He encouraged everyone to make an inventory and assessment of the parks for maintenance/repair projects that can be bid out. It would be beneficial to have a maintenance schedule for the parks.
