Subject: Furniture for New Township Building

Dear Board members,

At our January 15, 2026, special board meeting, the design team was requested to bring a dollar amount to be approved for furniture costs for our new building. However, we were still working on the furniture selection with NBS, and we did not have an actual quote.

With no solid cost information available, we picked a ballpark number of \$500,000. As we progressed through our planning, we discovered that we would likely need additional funds approved.

We now have our final cost, and the total comes to \$634,935.65. This results in the need for us to request approval for an additional (rounding up) \$135,000.

As you can see in the attached, we have been very cost-conscious and at \$18 per square foot, we are falling well below other consumers, some of which are fiscally responsible non-profit organizations. The closest comparison is the Easterseals MORC at \$21 per square foot.

We would like to point out that there will be a price increase to all product lines coming in August of this year that we are hoping to avoid.

The design team, which consists of myself, Deputy Treasurer Kim Patton, and Trustee Liz Smith, requests approval for an additional \$135,000 for the purchase of furniture for the new Township building.
