

ORDINANCE No. 2026-O-19

**AN ORDINANCE AMENDING SUBSECTIONS 11.16.150
STREET INDEX OF PARKING RESTRICTIONS AND 11.22.010 NO STOPPING,
STANDING OR PARKING**

WHEREAS, the changes prescribed below in the Street Index of Parking Restrictions were reviewed by the Public Works Committee and recommended for approval by said committee; and,

WHEREAS, Subsection 11.22.010 needs to be updated to reflect the changes made within Subsection 11.16.150; and,

The Common Council of the City of Whitewater, Walworth and Jefferson Counties, Wisconsin, do ordain as follows:

SECTION 1. Whitewater Municipal Code Chapter 11.16 Subsection 11.16.150 is hereby amended by deleting the following from the Street Index of Parking Restrictions:

<u>S.</u>	<u>Elizabeth St</u>	<u>West side; from a point 115 feet north of the north curbline of W Melrose, south to a point 553 feet south of the north curbline of W Melrose</u>	<u>11.22.010</u>	<u>No stopping, standing or parking</u>
<u>S.</u>	<u>Elizabeth St</u>	<u>East side; along entire frontage of 401 S Elizabeth (Middle School)</u>	<u>11.16.080</u>	<u>No parking</u>
<u>S.</u>	<u>Elizabeth St</u>	<u>West side; from Kay St south to W Walworth</u>	<u>11.16.080</u>	<u>No parking</u>
<u>S.</u>	<u>Elizabeth St</u>	<u>East side; along entire frontage of 401 S Elizabeth (Middle School)</u>	<u>11.16.080</u>	<u>No parking</u>
<u>S.</u>	<u>Elizabeth St</u>	<u>Both sides; commencing at intersection with W Highland, thence south to southern terminus</u>	<u>11.16.125</u>	<u>Two-hour parking from 8:00 a.m. to 4:00 p.m. except Saturdays, Sundays, and holidays.</u>

SECTION 2. Whitewater Municipal Code Chapter 11.16 Subsection 11.16.150 is hereby amended by adding the following to the Street Index of Parking Restrictions:

<u>S</u>	<u>Elizabeth St</u>	<u>West side; from 115 feet north of Melrose Street to Kay Street</u>	<u>11.22.010</u>	<u>No stopping, standing or parking</u>
<u>S</u>	<u>Elizabeth St</u>	<u>West side; from Kay Street to Walworth Avenue</u>	<u>11.16.125</u>	<u>Two-hour parking from 8:00 a.m. to 4:00 p.m. on school days</u>
<u>S</u>	<u>Elizabeth St</u>	<u>East side; from cul-de-sac to southern property line of 401 S Elizabeth Street (Middle School Property)</u>	<u>11.16.125</u>	<u>Two-hour parking from 8:00 a.m. to 4:00 p.m. on school days</u>
<u>S</u>	<u>Elizabeth St</u>	<u>East side; adjacent to 401 S Elizabeth Street (Middle School Property)</u>	<u>11.22.010</u>	<u>No stopping, standing or parking</u>
<u>W</u>	<u>Highland St</u>	<u>South side; from west property line of 1057 W. Highland Street, west 75 feet</u>	<u>11.16.080</u>	<u>No parking</u>

SECTION 3. Whitewater Municipal Code Chapter 11.22 Subsection 11.22.010 is hereby amended to read as follows:

11.22.010 – NO STOPPING, STANDING OR PARKING

The stopping, standing or parking of any vehicle by the owner or operator shall be prohibited on streets so designated in the table in Section 11.16.150 of this chapter.

SECTION 4: All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 5: This ordinance shall take effect and be in force the day after its passage and publication.
