## RESOLUTION TO CREATE THE LINNIE LAC MANAGEMENT DISTRICT

WHEREAS, The residents and property owners around Linnie Lac are seeking to develop a lake protection and rehabilitation district as provided in Wisconsin Statutes Chapter 33;

AND WHEREAS, the residents and property owners around Linnie Lac have determined that a unit of government is needed to handle current and future issues of Linnie Lac;

AND WHEREAS, the boundaries submitted for consideration for the district are shown on attachment #1;

AND WHEREAS, the residents and property owners around Linnie Lac have indicated that all the lands within the proposed boundaries of the district are benefited by the district;

AND WHEREAS, Wisc. Stats. 33.23(1) allow cities to create a district by resolution without the need for petitions or public hearings;

AND WHEREAS, the residents and property owners around Linnie Lac have indicated their intentions with their signatures on the petitions to the City to create a lake protection district;

AND WHEREAS, the residents and property owners around Linnie Lac have also indicated their desire to be self-governing as provided in Wis. Stats. 33.23(3) by submitting signatures of more than twenty percent of the owners of property in the district;

AND WHEREAS, the residents and property owners around Linnie Lac have selected the name of Linnie Lac Management District;

AND WHEREAS, the residents and property owners around Linnie Lac have submitted a list of residents to serve as interim board of commissioners of the district until the first annual meeting is held;

AND WHEREAS, the residents and property owners around Linnie Lac request the first annual meeting to be scheduled for July 26 at 1 p.m. at the New Berlin Library;

AND WHEREAS, the Common Council of the City of New Berlin finds and declares that (1) the proposed district is necessary, (2) the public health, comfort, convenience, necessity and welfare will be promoted by the establishment of the district, (3) the properties to be included within the district as herein provided will be benefited by the establishment of the district, and (4) the formation of the district will not cause or contribute to long-range environmental pollution as defined in Wisc. Stats. Sec. 144.01(3);

THEREFORE BE IT RESOLVED that the Common Council of the City of New Berlin do hereby create the Linnie Lac Management District, which is located wholly within the City of New Berlin as provided in Wisc Stats, Sec. 33.21(1);

BE IT FURTHER RESOLVED that the Common Council of the City of New Berlin do hereby establish the boundaries of the Linnie Lac Management District as set forth in the map labeled attachment #1 which is attached hereto and made a part hereof and is described as follows:

the centerline of College Avenue on the south, the centerline of Racine Avenue on the west, the centerline of the Rock Freeway on the north, and the east section line of the SE 1/4 of Section 32 on the east.

AND BE IT FURTHER RESOLVED that the Common Council of the City of New Berlin do hereby direct that the First Annual Meeting of the Linnie Lac Management District be held on July 26 at 1 pm at New Berlin Library;

BE IT FURTHER RESOLVED that the Common Council of the City of New Berlin shall notify the University of Wisconsin Stevens Point and the Wisconsin Department of Natural Resources of the creation of the Linnie Lac Management District.
