**Project:** Sectional Sewer CIPP Installation

Visu-Sewer is pleased to provide the following quotation for Sectional Sewer CIPP Installation:

Install four (4) 8" x 4' and two (2) 8" x 6' sectional liners in four (4) separate sanitary sewer lines for the City of Whitewater. Project includes one (1) pass with a jet for light cleaning prior to liner installations and reinstatement of up to three (3) sewer lateral connections. If needed, additional cleaning and removal of obstructions (e.g., roots, deposits, protruding laterals, etc.) will be completed at a T&M rate of \$395.00 per hour. Grouting to stop active leaks and heavy cleaning with a vactor will be quoted separately.

**Price: \$2,925.00 per sectional liner**      **17,750<sup>00</sup>**  
**(Minimum of six (6) sectional liners.)**

Above price assumes the pipe sections can be lined in their current condition. If it is determined that the damaged pipe cannot be lined, mobilization and/ or setup time will be incurred at a T&M rate of \$395.00/hour. Bypass pumping is not included.

City of Whitewater will need to provide drivable access to all manholes, water from nearby hydrants without charge, a dump site for captured debris and traffic control beyond cones and signs. If you have any questions, please do not hesitate to call us at 800-876-8478.

Project: Sanitary Sewer CIPP Installation

Visu-Sewer is pleased to provide the following quotation for CIPP installation:

**Install approximately 1,201 linear feet of 8" National Liner @ \$45.75 per linear foot                      \$54,945.75**

The above listed price is based on a video inspection dated between August 2019 and November 2020 and assumes the current pipe conditions are suitable for CIPP installation utilizing air pressure for the inversion and hot air/ steam for curing. Reaming of the cast iron pipe under the railroad tracks will be completed at a T&M rate to \$385.00 per hour. Project pricing does not include railroad liability insurance or railroad flaggers if required.

Pricing includes:

- Labor, material, and equipment.
- Mobilization and Traffic Control
- One (1) pass jet cleaning and televising of sewers prior to installation.
- Bypass pumping of existing flow.
- Installation of National Liner per manufacturer's instructions, ASTM 1216.
- Reinstatement of twenty (20) active service connections
- Televising of sewers after installation.

**NOTE:** Due to volatility in material pricing and availability this proposal is valid for 30 days from the date of origination. If a signed proposal has not been received within 30 days price(s) may be adjusted upon mutual agreement, or the proposal may be withdrawn by either party.

The City of Whitewater will need to provide: drivable equipment access to all manholes, water from nearby hydrants (without charge), a dump site for captured debris, and traffic control beyond cones and signs. If needed, removal of obstructions (e.g., roots, deposits, and protruding taps) will be completed at a T&M rate of \$385.00 per hour. Grouting of active leaks, and heavy cleaning will be quoted separately. If it is determined that current pipe conditions are not suitable for an air inversion and hot air/ steam cure, pricing may be adjusted to reflect alternate installation methods. Mobilization and/ or time on site will be billed at a T&M rate of \$385.00 per hour for pipe sections not suitable for CIPP installation. Thank you for the opportunity to quote on this project. All material is guaranteed to be as specified. All work to be completed in a substantial workmanlike manner according to standard practices or specifications submitted. Any alteration or deviation from the above specifications involving extra costs will be executed only upon written orders and will become an extra charge over and above the estimate.
