Going forward, I expect proclamation requests to be handled within your office from start to finish. That includes evaluating whether a request meets our standards, coordinating any necessary follow-up, and preparing a draft for my review and signature as appropriate.

WHEREAS, James R. Athas has served as Organist and Director of Music at the Whitewater First United Methodist Church for fifty (50) years, beginning during his college years at the University of Wisconsin–Whitewater, and during that time has provided musical leadership for thousands of worship services, weddings, memorials, and community gatherings; and

WHEREAS, throughout his tenure, Mr. Athas has demonstrated exceptional musical range and technical skill, including composing and arranging original works, performing traditional sacred and organ music, leading choirs and cantatas, and supporting larger musical productions and performances hosted in Whitewater that have drawn broad community participation; and

WHEREAS, Mr. Athas has consistently shared his talents beyond his home congregation, supporting other churches when needed, providing music for senior living facilities, outdoor and seasonal services, ecumenical celebrations, and longstanding civic traditions such as the annual July 4th services at Cravath Lake, as well as participating in charitable and community fundraising efforts; and

WHEREAS, through his steady presence and quiet professionalism, Mr. Athas has contributed to the cultural life of Whitewater in ways that extend well beyond any single institution, with his

professional and personal life closely connected to the City across multiple generations of residents;

He played for 3 choirs as part of a city/school district/ecumenical fundraiser, "Sing a Song for Haiti" to raise money for hurricane victims.</p> <p>During the dark ages of Covid, Jim recorded music weekly, sharing it on the internet and the FUMC site, to inspire all in the Whitewater community - playing organ, piano, keyboard,</p>

hammer dulcimer and pulling together family members to add a voice. He bouyed the spirits of all. Jim's talents are boundless and he shares them generously in his quiet manner.

Starting his FUMC organist career in his college years at UW-Whitewater, his life has been well documented through his musical and personal growth in the church these past 50 years. Falling in love, graduating, first job, marriage, birth of 4 children, their marriages, grandchildren, were all part of this spectacular carreer spanning 50 years right here in Whitewater. Jim's music and life are an inspiration to all who have experienced his music in the community. This is a most deserving celebration of an extraordinary person.
