<p>On Wednesday October 1st, 2025, at approximately 7:02 AM, I, Officer Bridleman, was dispatched to a call about a street sweeper pulling a wire down from 637 E Cravath St, City of Whitewater, County of Walworth, State of Wisconsin. Upon arrival, I observed a wire wrapped around an electrical pole, as well as the electric mast hanging from the house. Also, there was caution tape blocking the driveway of the house. The down wire appeared to be a cable wire. I talked with the driver of the street sweeper, identified via WI DL as James T. Jaquith (M/W 12/15/1992). Jaquith stated that he was backing up to redo a spot on the road and accidentally pulled the wire down. It appeared there was no damage to the city street sweeper. While talking with the city crew, they advised they tried to knock on the front door and no one answered.</p> <p>After I got the information from Jaquith, I knocked on the front door of 637 E Cravath St but no one answered. Officer Ellis saw a motorcycle in the driveway and ran the plates. It returned to Steven J. Sweeney (M/W 02/08/1977). While I was on my way back to my squad car a vehicle flagged me down. The driver identified himself as Sweeny. I informed him of everything that happened. Ofc. Ellis gave him a business card with this case number. No further follow up is needed. This report will be forwarded to the City of Whitewater Finance Department.</p>
