16 17 18	WHEREAS , Ordinance 2024-006 amended WMC Chapter 3.08 to remove the seasonal exemption and impose sales tax year-round, along with other amendments; and
19 20 21 22	WHEREAS , during its July 15, 2025 Regular Meeting, the City Council discussed community interest in returning to a six-month seasonal sales tax period and voted to direct administration to prepare a resolution placing a non-binding advisory question on the October 2025 regular election ballot; and
23 24 25	WHEREAS , the purpose of this advisory question is to gauge voter sentiment and provide guidance to the City Council;
26 27	NOW, THEREFORE, THE WHITTIER CITY COUNCIL HEREBY RESOLVES:

The following non-binding advisory question shall be placed on the ballot and submitted to the qualified voters of the City of Whittier at the regular municipal election on October 7, 2025. The results of the vote on this question shall be advisory only and shall not be binding on the City Council.
