**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, ALASKA,
AUTHORIZING ADDITIONAL FUNDING IN THE AMOUNT OF \$10,020 UNDER THE
EXISTING TERM CONTRACT WITH CRW ENGINEERING GROUP, INC. FOR AN
EXPANDED FEASIBILITY STUDY AND STAKEHOLDER COORDINATION
RELATED TO MOUNTAIN GOAT COURT AND RESERVOIR ROAD AND
APPROPRIATING FUNDS**

WHEREAS, the City of Whittier authorized Task Order #33a with CRW Engineering Group, Inc. (CRW) on December 31, 2025, to complete a feasibility study evaluating development opportunities associated with Mountain Goat Court; and

WHEREAS, CRW completed the authorized scope of work and submitted a Draft Mountain Goat Court Feasibility Study on February 10, 2026, which identified additional areas with development potential beyond the original study area; and

WHEREAS, the City requested a proposal from CRW to provide an expanded feasibility study to further evaluate these potential development opportunities, clarify design considerations, support stakeholder coordination, and prepare materials to assist the City Council in future decision-making; and

WHEREAS, the City Council finds that obtaining additional feasibility-level information and stakeholder input is in the best interest of the City to support informed planning decisions and responsible evaluation of future development opportunities.

NOW, THEREFORE, THE WHITTIER CITY COUNCIL HEREBY RESOLVES:

Section 1. The City Council hereby authorizes the City Manager to approve additional funding in the amount of \$10,020 under the existing term contract with CRW Engineering Group, Inc. for an expanded feasibility study and stakeholder coordination services related to Mountain Goat Court and Reservoir Road and Appropriating Funds.

Section 2. This authorization is limited to feasibility analysis, planning support, and stakeholder coordination and does not constitute approval of future design, construction, or development activities.

Section 3. The City Council directs staff to return to Council with recommendations and findings prior to initiating any subsequent phases of work related to development, design, or construction in the Mountain Goat Court or Reservoir Road areas.

Section 4. This resolution shall be effective immediately upon adoption.
