Sponsored by: Wilde 1 2 3 4 CITY OF WHITTIER, ALASKA 5 **RESOLUTION 2025-024** 6 7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, ALASKA, 8 AUTHORIZING THE REAPPROPRIATION OF 2024 MOTOR POOL FUNDING FOR 9 THE PURCHASE OF A POLICE CRUISER AND ASSOCIATED PATROL UNIT 10 EQUIPMENT IN AN AMOUNT NOT TO EXCEED \$60,000, AND APPROPRIATING 11 **FUNDS** 12 13 WHEREAS, the Whittier City Council previously appropriated \$60,000 in the 2024 14 Budget for the purchase of a Police Patrol Unit and related patrol equipment; and 15 16 **WHEREAS**, as a result of significant inventory backlog resulting from COVID-era delays, 17 the Whittier Police Department had a difficult time finding a police cruiser that could be ordered 18 and received prior to the end of 2024, causing delays in delivery of the vehicle; and 19 20 WHEREAS, the police cruiser that was ordered in 2024 has been received and is in the 21 shop being outfitted with necessary patrol equipment, but because the funding budgeted for this 22 item was appropriated in a prior year, and unspent prior year appropriations do not carry over from 23 one to the next, it is necessary to re-appropriate the funds into 2025 for this purchase. 24 25 NOW, THEREFORE, THE WHITTIER CITY COUNCIL HEREBY RESOLVES: 26 27 **Section 1.** Funding in an amount equal to \$60,000 is hereby appropriated from the Motor 28 Pool Reserves account no. 60-000-3000 to the Motor Pool Capital Equipment account no. 60-900-29 9520, in the same amount as was budgeted and unspent in 2024. 30 31 **Section 2.** The City Manager is hereby authorized to execute all documentation necessary 32 to secure the purchase of this vehicle and related equipment. 33 34 **Section 3.** Any costs in excess of \$60,000 for the purchase and outfitting of the patrol 35 vehicle are to come from the Police Department's 2025 Budget. 36 37 **Section 4.** This resolution shall be effective immediately upon adoption. 38
