THIS AGREEMENT, made this 10th day of November 2025, by and between CITY OF WILLARD, MISSOURI hereinafter called "OWNER" and YOUNG'S GENERAL CONTRACTING, INC. doing business as a corporation hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

- 1. The CONTRACTOR will commence and complete the construction of the <u>"94" LIFT STATION UPGRADE AND</u> FORCE MAIN REPLACEMENT.
- 2. The CONTRACTOR will furnish all of the materials, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.
- 3. The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS on the date as stipulated in the NOTICE TO PROCEED and will complete same within <u>270</u> consecutive calendar days unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS. The CONTRACTOR agrees to pay as liquidated damages to the OWNER the sum of <u>\$500.00</u> each consecutive calendar day thereafter as provided in Section 15 of the General Conditions.
- 4. The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum <u>FOUR MILLION EIGHT HUNDRED SIXTY-SIX THOUSAND SIX HUNDRED THIRTY-FIVE AND 00/100 DOLLARS (\$4,866,635.00)</u>, or as shown in the BID Schedule.
 - 5. The term "CONTRACT DOCUMENTS" means and includes the following:
