

I'm reaching out about a new opportunity that has been presented to me in the same building. There used to be a salon at 31601 Vine Street Suite 101, I would like to move the infants and toddlers from their current room, into that space to provide more room for them to learn and grow. Also, to reduce the noise level in the building, being next door to the BMV and sharing space with preschoolers who are on completely different schedules. Having the additional space will level up our program tremendously, allowing us to have separate spaces for infants/toddlers, preschoolers, and schoolagers.
