### Discussion regarding the moratorium on recreational marijuana with an expiration date of November 21st, 2024

Mayor Vanni was present to speak on the moratorium on recreational marijuana with an expiration date of November 21st, 2024. He also provided a handout to the members for their review regarding the moratorium on recreational marijuana. He stated that at this time only dual license applications are being accepted by the state, those with medical license can obtain a recreational license first and there have been about 110 so far. The City of Willowick currently does not have a medical dispensary. There was some discussion on surrounding cities that have medical dispensaries. He stated on an individual basis he does not believe there will be movement until the end of the year as the state is still sorting out details. He advised that we (the City of Willowick) have to make a decision on what kind of plan we want to put into place, such as "do we want to have a dispensary/store front here", he advised that he believes the state is only going to allow about 300 licenses meaning it will not be an overabundance attempting to come into the city. However, a decision has to be made, he also advised that we can extend the moratorium if the state still does not have anything in place. Mayor Vanni stated that personally, his opinion would be to allow one in the city for the purpose of tax income for the city, however only allowing one in the city and there will be requirements regarding proximity to schools and/or daycares. There was some previous discussion regarding radius in regard to the allowable locations, that conversation was continued at this time, it seems the only location that would be available would-be Euclid Avenue. Mayor Vanni stated at the end of November Willowick City Council is either going to need to extend the moratorium or we need to come up with a new ordinance allowing recreational marijuana sales in the city with requirements/parameters. Mayor Vanni referred to the documents he provided at the beginning of the meeting regarding what other cities have in place pertaining to recreational marijuana as his clerk has been following the ordinances and obtaining information. He advised the board to review those documents provided, there was some discussion regarding the difference between medical and non-medical marijuana, the state requirements and additional details regarding regulation of recreational marijuana. There was also further discussion on keeping the moratorium in place, extending it another 6 months, until we have distinct guidelines from the State of Ohio. It was asked if the city has received any inquiries about coming into the city, Mayor Vanni stated that there has been a couple phone calls inquiring. There was some discussion regarding zoning amongst the board members, Mayor Vanni and Councilman Phares. The board has decided to not make any decisions at this meeting as they would like to further review other cities requirements, wait for further requirements from the State of Ohio and then move forward from there. Mr. Foisel discussed the schedule of marijuana currently federally being classified a schedule one drug and may be moved to a schedule three in 6 months, there has been a lot of public outcries for it to be changed due to a change in perception from the public so that has pushed in a lot of states to allow it in some capacity. There was some discussion regarding the schedule of drugs and alcohol. There was a review of the current moratorium on recreational marijuana. Chairman Carden asked the board to review and provide their thoughts to him, he will then compile the thoughts together to provide at our next meeting. There was some discussion regarding the sales tax and what the possible income to the city would be, further

discussion regarding the regulations as well as the percentage of Willowick residents that voted for recreation marijuana. At the next Planning Commission meeting the board will provide their thoughts on their reviews and discuss further.

#### Adjournment

Prior to adjourning the meeting there was some discussion regarding Planning Commission vacating the August meeting due to the history of vacating August's Planning Commission meetings we will reconvene September 9th, 2024.
