2. Consideration & Action: Preliminary Plat for approximately 82.37 acres of land, situated in the McCarver Survey, Abstract 910, the W. Franklin Survey, Abstract Number 468, The M.M. Edwards Survey, Abstract 1955, & the J.B. Wynn Survey, Abstract 1637, in the Extraterritorial Jurisdiction of the City of Willow Park, Parker County, Texas.

Bryan Holland of Skorburg Company, Developer, presented a slide show for this proposed residential project, "The Bluffs of Willow Park", for the Preliminary Plat brought forth.

One of the public comments suggested that a portion of the proposed subdivision plat was overlaid atop a 20-acre parcel which was annexed into the city limits in 2021, which would prohibit approval of the plat. Toni Fisher, ACM - Development, advised the Commission that this was not realized during Staff's [preliminary] review and

explained that a parcel that was already zoned within the city could not be approved as another designated zone via plat, but only as a zoning change. Fisher suggested that the Commission table the agenda item until staff could further research the alleged annexation.
