MAYOR'S BUSINESS [7:05 PM] Good evening.

I hope everyone had a relaxing and enjoyable Labor Day weekend. With school now back in session, summer vacations may be winding down, but our calendars are filling up again with sports, clubs, and other school activities. It's an exciting time of year for students and families alike, especially those reaching new milestones—like entering high school.

I want to take a moment to wish all our students, parents, teachers, and school staff a smooth and successful start to the new school year. And let's all do our part to keep our community safe: please drive carefully, obey school zone speed limits, and watch out for children as they head to and from school.

With that I would like to make the following report to Council and our Community:

## **MEETING WITH CFM ADVOCATES**

I want to take a moment to update everyone on one of our City Council goals: building trust through better communication and engagement. That means engaging the community on urban renewal and infrastructure funding, creating a Town Center communication strategy, and improving online tools so more residents can connect with the City. We are making progress.

As part of this effort, each Council member has met with the City's consultant, CFM Advocates to share their thoughts and ideas. I met them first. In that meeting I once again advocated for a task force to be part of this global communication strategy—an idea I first proposed publicly in August of 2024 in an opinion piece I wrote at the time in the Wilsonville Spokesman. To emphasize the point, I gave them a copy of my article.

That said, I am one vote on Council. Each of my colleagues has their own ideas which need to be heard and respected as part of this global communication strategy. Once City staff, and the consultant present a full strategy for us to consider we as a council will decide next steps. If a task force is included, and once its parameters are defined, we will establish a fair process for selecting members, and we will make sure to share this with the community.

In the meantime, I understand the City is moving forward with three focus groups on Town Center and Urban Renewal—representing pro, con, and neutral perspectives. If you are interested in participating in the focus groups please reach out to our City Manager by email, and let him know your interest and what focus group you wish to be on. In the meantime, I really encourage everyone who has not yet read the extensive town center plan materials to go to the City's website to educate yourself about it.

## Tour with Rep. Rieke Smith

In mid-August, on one of the hottest days of the summer, Representative Sue Rieke Smith and I joined city staff for a whirlwind tour of Wilsonville. We visited SMART's operations facility, affordable housing under construction at Vuela, our constrained wastewater treatment plant, Town Center, and employment lands at Coffee Creek and Basalt Creek.

There's no substitute for seeing these projects firsthand. This tour will help us tell Wilsonville's story and strengthen our advocacy in Salem.

### Sen. Woods Memorial

On August 13, the City held a memorial for the late Senator Aaron Woods at Town Center Park. Speakers included Senator Courtney Neron Misslin, former mayors Tim Knapp and Julie Fitzgerald, Clackamas Community College President Tim Cook, and other community leaders.

The service was well attended by council, staff, legislators, and community members, with Aaron's family traveling from Colorado. We also dedicated a park bench in his memory—a lasting tribute to his leadership and kindness.

#### **OMA Conference**

Also in August, I attended the Oregon Mayors Association conference in Baker City. This is attended by mayors statewide, and is an opportunity to formulate shared goals and needs so we have some influence in Salem. Regardless of size or geography, cities across Oregon share many of the same challenges: local funding, housing affordability, access to good jobs, healthy communities, protecting local character, and the challenges with unfunded mandates coming from Salem. These conversations remind us that Wilsonville is part of a larger story across the state.

# PGE Power Together open house for Wilsonville Residents

On August 19, I attended Portland General Electric's open house at Clackamas Community College on their grid modernization efforts. Neighbors—particularly from the Stafford Road area—shared concerns about how decisions are being made on power line placement and other infrastructure issues. We are fortunate in Wilsonville that the City requires PGE to place many of our lines underground, something neighbors spoke positively about during the event.

The discussion was a valuable reminder that portions of our grid are outdated, and that while we need to support upgrades, each of us also has a role to play in using energy wisely and efficiently. From my perspective, it's natural to feel frustrated about higher utility bills or the pace of change at PGE. But perspective matters: compared to some of the serious challenges our neighbors in California are facing with Pacific Gas and Electric, we are fortunate to have a more stable and reliable system here in Oregon.

PGE also announced plans to form regional community advisory groups. I encourage Wilsonville residents to apply—this is a great opportunity to have our community's voice heard in what PGE does moving forward.

### **Boone Bridge Progress Meeting**

The Boone Bridge Seismic Resiliency Project remains Wilsonville's top legislative priority. Thanks to Senator Courtney Neron Misslin, the Legislature approved \$1 million for early engineering work.

I joined Senator Neron Misslin, Representative Rieke Smith,
Congresswoman Salinas' staff, ODOT Director Kris Strickler, and others to discuss how best to use these funds and pursue additional resources. ODOT recommended beginning with a geotechnical study—an underground look at soil and rock conditions—which was widely supported.

I continue to stress the need for a broader coalition. The Boone Bridge is not just a Wilsonville concern—it's regional, West Coast,

and national. Transportation companies, major employers, developers and regional mayors to highlight just a few all have a stake in ensuring the bridge is seismically sound and widened to meet future traffic demands.

And just for perspective: even if we had all the funding today, replacement would still take more than 7 ½ years to complete. That's why keeping this project front and center is so critical.

## All things Rotary:

Turning to all things Rotary. On August 7, I attended the last Rotary Club of Wilsonville summer concert series for the year, enjoying the Norman Sylvester Band. It was a great turnout, and the music and vocals were just great.

Last week I was also invited to speak at Rotary. I discussed our Council goals, and priorities, and my perspective on how we should move forward as a community. I was grateful for the opportunity to speak.

## **Legislative Special Session**

Beginning Friday, August 29, the Legislature convened a special session to discuss transportation funding. The effort, led by Governor Kotek, seeks to backfill operations and maintenance funding for ODOT as revenue from the gas tax declines because of fuel-efficient vehicles.

The proposal raises the gas tax and other fees, including extra fees on fully electric and highly-efficient vehicles and sets in motion a transition to a road user charge where people pay to support our road system based on miles traveled rather than fuel efficiency, leveling the playing field.

It also temporarily doubles the 0.1% payroll tax that funds transit to 0.2% until January 1, 2028. SMART would receive additional funds to support new vehicles, service enhancements, and other benefits.

Following two public hearings totaling around six hours and thousands of written comments submitted, the Oregon House passed the transportation proposal over Labor Day weekend. The bill is now awaiting action in the Senate, which is delayed until September 17.
