Vice Chair Candrian confirmed that all three Board members present were available to attend on November 14, 2024, so there would be a quorum. He further stated a suggested motion of continue to a time and date certain of November 14, 2024 at 6:30 p.m.

Clark Hildum moved to continue the public hearing on Resolution No. 438 to 6:30 pm on November 14, 2024 time and date certain. The motion was seconded by Jordan Herron and passed 3 to 0.
