Questions from Councilor Cunningham

Applicant's name: Patrick Thom

1. What criteria would you use in your decision-making process as a member of the City Council?

The criteria I would use in my decision-making process would be parallel to how I go about making other big decisions: I would read into the topic or item that is being discussed, taking into account pros and cons of why the topic is good or bad, will do well or not for the community or the group that it would aim to effect, and then listen in to those who have a stronger knowledge or professional insight if possible. From there, if available, I would gain insight from points that others had of the topic or item, to garner any similar mindsets, or receive other points of view I hadn't thought of while looking into whether it would be something to vote for or against.

- 2. Given the City Manager's comments in the FY 2025-2026 Budget introduction, how would you work to make the general fund more resilient?
- I would want to look at reasons as to why the development of growth in the city has been declining, as well as ways to reprioritize projects and what other options for grants or community assistance in providing the high quality we wish to provide for the residents and visitors of Wilsonville. Even in the current economic climate and uncertainty of where money from State and Federal grants or funding may or may not come, there must be community connections that can be explored to assist in strengthening the general fund by allowing it to grow without a need to pull more from it.
- 3. The city will receive a \$6.45 million lease payment in FYE 2027. If you could spend that money on anything, what would it be and why?
- I would spend that money at looking to build through existing infrastructure a performing arts center and gallery for the city, and/or a pool and rec center that can be built within current vacant structures and could build into the existing urban growth plan of the city center. Both would provide not only space for community growth, but would also allow the residents and visitors to enjoy classes, performances, games and artwork put on by their community members. It would also be another stream of revenue for the city to expand on current programs offered, but also would create more work and space for community learning, expanding on current offerings of classes to more life skills, including cooking, public speaking, performance, or lifeguarding, for example.
