## **ISSUE BEFORE AGENCY:**

A supplemental budget resolution for the FY2022-23 budget year.

## **EXECUTIVE SUMMARY:**

Oregon's Local Budget Law allows the URA Board to amend the adopted budget for an occurrence or condition that was not known at the time the budget was adopted. The Fiscal Year 2022-23 Budget was adopted by the Agency on May 19, 2022

#### **Budget Adjustment Resolution**

This supplemental budget includes the re-appropriation of funds from the prior fiscal year for capital projects (CIPs) that were started but not completed in that fiscal year. The CIP rollover request of \$1,929,116 includes \$1,809,116 of direct costs and \$120,000 of overhead costs, as detailed in the attached, Exhibit A.

#### **EXPECTED RESULTS:**

The Urban Renewal Districts are required to amend their respective annual budget in accordance with Oregon local budget law. It is required to have the supplemental budget adjustment approved by the Board during a public hearing at a regularly scheduled meeting.

#### TIMELINE:

As required by Local Budget Law, a notice for the public hearing has been published in the Wilsonville Spokesman on October 5, 2022 and October 12, 2022. The adoption of the Supplemental Budget Adjustment is required prior to the end of the fiscal year, June 30, 2023.

#### **CURRENT YEAR BUDGET IMPACTS:**

## COMMUNITY INVOLVEMENT PROCESS:

The public hearing will be held on October 17, 2022 as a part of the adoption process.

## POTENTIAL IMPACTS OR BENEFIT TO THE COMMUNITY:

The amended budget provides for the delivery of services and construction of capital projects throughout the community.

Not approving the attached supplemental budget could result in overspending current budget appropriations. The City is required to disclose all excess of expenditures over appropriations in the Annual Comprehensive Financial Report (ACFR).
