## **ISSUE BEFORE COUNCIL:**

Approve a grant of financial assistance to Wilsonville Community Sharing for fiscal year 2022-23.

#### **EXECUTIVE SUMMARY:**

The City of Wilsonville has provided financial support for the administrative and operational services of Wilsonville Community Sharing (WCS) for more than 20 years. The annual Support Grant Agreement between the City of Wilsonville and Wilsonville Community Sharing (WCS) expires June 30, 2022 and the attached agreement will extend through June 30, 2023.

The FY 2022 – 23 Approved Budget includes \$56,373 for the annual support grant. This includes \$16,000 for utility bill payment assistance and \$40,373 for a general purposes which is dedicated to, but not limited to, providing staffing, food, prescription help, rent and housing support and other services to those community members in need. It has been standard practice to adjust the general purposes grant annually based on the consumer price index (CPI). The FY 2022/23 budget includes a \$2,782 increase, representing a 7.4% year over year CPI-West Size A indexed, from \$37,591 (FY 2021-22).

#### **EXPECTED RESULTS:**

The expected result of this agreement is to continue support of Wilsonville Community Sharing.

#### TIMELINE:

This resolution and agreement would be effective from July 1, 2022, through June 30, 2023.

#### **CURRENT YEAR BUDGET IMPACTS:**

There are no current year budget impacts. For FY 2022-23, \$56,373 has been budgeted in the City Administration Department in the General Fund.
