## **Recent Meetings and Events**

### **C4 Metro Subcommittee – December 17**

At the December meeting of the C4 Metro Subcommittee, we heard an update from TriMet on service levels and the challenges they are facing region-wide. Seeing that broader context was a good reminder of the strength of Wilsonville's own transit system, SMART, and the high level of service it provides to our residents, employees, and visitors.

### **League of Oregon Cities – Revenue Reform Meeting – December 17**

Also on December 17, I attended a regional meeting hosted by the League of Oregon Cities President, Mayor Jessica Engelke of North Bend. This was one of several meetings she is holding around the



state to gather input from cities as LOC examines municipal finance and long-term revenue stability.

### **Washington County Mayors and Chair Meeting – December 17**

Later that day, I joined the monthly Mayors and Chair meeting with Washington County Chair Kathryn Harrington. These meetings help strengthen city-county collaboration and give us the opportunity to share challenges, ideas, and best practices across the region.

### **CIS Collaboration Center Open House – December 17**

To close out a full day, I spoke at the ribbon cutting and open house for the CIS Collaboration Center on Kinsman Road. CIS—City-County Insurance Services—provides insurance services to cities and counties across Oregon, including Wilsonville. We're proud to welcome them to our community and to see them investing in a beautiful new space here.

### **Boone Bridge Task Force – December 18**

On December 18, a growing group of stakeholders came together to continue advancing the reconstruction of the Boone Bridge. Legislators, congressional staff, ODOT leadership, and city representatives discussed project status, debriefed our October trip to Washington, D.C., explored ways to broaden public and private support, and talked about how to keep momentum moving forward. I'm grateful for the collaborative spirit this group continues to bring to this long-standing regional priority.

I had the pleasure of joining Wilsonville residents last night for the Second Annual "Light Up Wilsonville" Menorah lighting.

## **Las Posadas Celebration – December 18**

That evening, I had the opportunity to attend the Diversity, Equity, and Inclusion Committee’s third annual Las Posadas celebration. The event featured performances by the West Linn–Wilsonville School District Folklórico dancers and the Woodburn High School Mariachi Band, along with crafts, tamales, pan dulce, and hot chocolate. The evening wrapped up with a piñata and traditional *aguinaldos*. This celebration would not be possible without the generous support of Oregon State Credit Union, and I want to thank everyone who helped make it such a joyful community event.
