On June 25, the Wilsonville Police and Clackamas County Sheriff's Office partnered with the Oregon Department of Transportation (ODOT) in a joint operation targeting unauthorized moving companies. Several drivers were cited or educated during the effort. The operation aimed to ensure that businesses advertising moving services in Clackamas County meet state safety and integrity standards. Oregon's moving industry is heavily regulated to protect both personal safety and property. Individuals with concerns or complaints about a household move can contact the Department of Justice Consumer Protection Division. The second commendation stemmed from her role as the primary deputy in the case of a missing 10-year-old autistic child. Deputy Campos demonstrated exceptional communication with all involved and coordinated a swift, efficient law enforcement response. The child was safely located within just 10 minutes.
