## **RESOLUTION NO. 3207**

## A RESOLUTION OF THE CITY OF WILSONVILLE APPROVING MASTER PROFESSIONAL SERVICES AGREEMENTS FOR ON-CALL CIVIL ENGINEERING SERVICES AND RELATED SERVICES.

WHEREAS, since 2015, the City of Wilsonville ("City") periodically undertakes a formal, competitive procurement process to procure multi-year on-call engineering services and related services to provide professional services on an as-needed basis; and

WHEREAS, the City utilizes the resulting master professional services agreements to efficiently procure the professional services of qualified entities on an as-needed basis through task orders under the agreement(s); and

WHEREAS, on April 11, 2025, the City published a formal request for proposals for on-call engineering services and related services; and

WHEREAS, from the proposals submitted, the City selected thirty-five (35) consultants to perform, on an as-needed basis, one or more of the seventeen (17) categories of professional services; and

WHEREAS, a project task order under a master professional services agreement cannot exceed \$250,000, the limit of the City's administrative authority to approve contracts.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

Section 1. Findings. The above recitals and the staff report accompanying this Resolution constitute the findings of the City Council as if fully set forth herein.
