**4A. MAYOR'S BUSINESS – Recent Meetings, Events, Etc.**

With the holiday season upon us, it's good to take a moment to slow down and appreciate the people who strengthen our families and our community. As a **city of belonging**, we value people from all backgrounds and walks of life, regardless of what language

they speak, where they were born, how their family is structured, what values and beliefs they hold, or what holidays they celebrate.

## **Oregon State Credit Union Ribbon Cutting (Nov. 21)**

On **Friday, November 21, Oregon State Credit Union**, in partnership with the **Wilsonville Chamber of Commerce**, cut the ribbon on a new branch here in Wilsonville.

The Wilsonville location is Oregon State Credit Union's 16<sup>th</sup> branch, but we've felt Oregon State Credit Union's presence in Wilsonville long before the doors opened. They are active in the **Wilsonville Rotary Club** and have **sponsored Wilsonville Diversity, Equity, and Inclusion (DEI) Committee events** including Juneteenth, Pride, and Las Posadas. Before ever opening their doors in our community, Oregon State Credit Union has **sponsored or pledged over \$30,000 dollars** for these events!

Thank you to Oregon State Credit Union for being a positive force in our community, and to the Wilsonville Chamber for helping welcome them to the community so warmly.

## **4B. MAYOR'S BUSINESS – Upcoming Meetings, Events, Etc.**

### **Rosa Parks Day (Dec. 1)**

Today is **Rosa Parks Day**, the **70<sup>th</sup> anniversary** of her infamous arrest on December 1, 1955 for refusing to give up her seat on a Montgomery,

Alabama bus to a white man who had just boarded. Her action led to the Montgomery Bus Boycott, an influential part of the Civil Rights Movement, and the eventual desegregation of transportation.

## **Sewer and Stormwater Utility Fee Open Houses (Dec. 2)**

Wilsonville residents and business operators are invited to attend one of two **public open houses tomorrow, December 2** about the City's **sewer and stormwater utility rates**. The events are identical and being offered twice to accommodate more community members. The first will be tomorrow, December 2 from **4:00-6:00pm** and the second is from **7:00-9:00pm**. Both sessions will be in the **Willamette River Conference Room on the second floor here at City Hall, 29799 Southwest Town Center Loop East**.

Each session will begin with a presentation by City staff detailing the results of the recent Sewer and Stormwater Rate Review, which recommended **adjusting the fee structure** for residents, businesses, and developers to fund about **\$240 million in new capital projects over the next 20 years**. Attendees will have the opportunity to ask questions of the project team after the presentation.

Despite steep inflationary cost increases and aging infrastructure, these fees have **remained static** for years. The sewer fee was last adjusted in **2014**, stormwater fees have been unchanged since **2021**. If adopted, the new rate schedule would increase year-over-year fees from 2026-

2029 to catch up from the static years and build a regular inflationary adjustment into subsequent years.

The proposed rate adjustment has been informed by work sessions with the City Council on April 21 and November 3. **On December 15, City Council will hold a public hearing and consider adoption of the new fee structure.**

### **International Day of Persons with Disabilities (Dec. 3)**

**December 3 is International Day of Persons with Disabilities**, a day to honor the ongoing international campaign to promote the rights and well-being of people living with a disability across the world. According to the United Nations, an estimated 1.3 billion people—or 1 in 6 of us—experience a disability. The day is one way to promote an understanding of disability issues, mobilize support for the rights and dignity of people with disabilities, and to recognize the countless ways people with disabilities contribute to our social, economic, and cultural fabric.

### **Brown Road Improvements Open House (Dec. 3)**

The City invites community stakeholders to share their thoughts and learn what's next for the **Brown Road Improvements Project** at an **open house on Wednesday, December 3 at Inza R. Wood Middle School**. Drop in any time between **5:30-7:30pm** to talk to the project team and share your ideas for consideration.

The Brown Road Project will upgrade Brown Road between SW Wilsonville Road and SW Evergreen Drive to more closely meet current City standards more closely.. Planned improvements include adding a shared-use path and making access to adjacent neighborhoods safer.

### **Tree Lighting Ceremony (Dec. 4)**

On **Thursday, December 4 at 5:00pm**, join City Council and Wilsonville Parks and Recreation for the **annual tree lighting ceremony in Town Center Park**. Bundle up and join the free, family-friendly festivities with choral performances, hot cocoa, pictures with Santa, a “Letters to Winter Wonderland” station, and more. Thank you to **Nichols Family Agency** for their generous sponsorship.

### **Toy Drive and Senior Stockings (ongoing through December 8)**

A reminder that Wilsonville Parks and Recreation's **annual toy and stocking drive is happening now**.
