UNDER COUNCILOR CONCERNS, I WANT TO TAKE A FEW MOMENTS TO SHARE SOME SMALL BUT IMPORTANT UPDATES ABOUT HOW I'LL BE MANAGING OUR COUNCIL PROCESSES MOVING FORWARD.

THESE AREN'T IN RESPONSE TO ANY ONE PERSON OR SITUATION

— RATHER, THEY'RE COURSE CORRECTIONS TO HELP MAINTAIN A
FAIR, ORDERLY, AND PRODUCTIVE ENVIRONMENT, ESPECIALLY AS
OUR DISCUSSIONS BECOME MORE COMPLEX OR HIGH-PROFILE.

FIRST, I'VE BEEN FAIRLY INFORMAL IN USING THE NOTIFICATION MONITOR TO RECOGNIZE COUNCILORS WHO WISH TO SPEAK.

THAT APPROACH WORKED WELL — UNTIL IT DIDN'T. IN MEETINGS WHERE MANY WANT TO WEIGH IN, LACK OF STRUCTURE CAN CREATE CONFUSION OR FRUSTRATION.

SO, FROM NOW ON, I'LL BE RECOGNIZING COUNCILORS SOLELY THROUGH THE MONITOR FEATURE. THIS ENSURES FAIRNESS AND CLARITY IN THE ORDER OF PARTICIPATION. I WILL CALL ON COUNCIL PRESIDENT BERRY TO ASSIST ME WHEN I GET BUSY RUNNING THE MEETING TO HELP ME KEEP AN EYE ON THE MONITOR.

SECOND, FOR AGENDA ITEMS EXPECTED TO GENERATE SIGNIFICANT DISCUSSION, I'LL BE ASKING EACH COUNCILOR TO BEGIN WITH NO MORE THAN TWO QUESTIONS.

IF YOU HAVE MORE, JUST LET ME KNOW. I'LL CHECK THE MONITOR, AND IF NO OTHER COUNCILOR IS WAITING, YOU'LL BE WELCOME TO CONTINUE.

IF SOMEONE ELSE IS IN THE QUEUE, I'LL CALL ON THEM AFTER YOUR SECOND QUESTION IS ANSWERED, AND WE'LL CONTINUE IN THAT ROTATION UNTIL ALL QUESTIONS ARE ADDRESSED.

TO BE CLEAR, IF YOUR QUESTIONS ARE NOT ADDRESSED BY ANOTHER COUNCILOR, I WILL COME BACK TO YOU IN THE END IN ORDER TO ALLOW YOU THE OPPORTUNTIY TO ASK ANY REMAINING QUESTIONS THAT WERE NOT ANSWERED THAT YOU HAVE.

THIS ENSURES EVERYONE HAS AN OPPORTUNITY TO ENGAGE, WHILE KEEPING THE MEETING FOCUSED AND EFFICIENT.

THIRD, IF YOU PLAN TO SHARE DEMONSTRATIVE MATERIALS OR DOCUMENTS THAT ARE OUTSIDE THE RELEVANT COUNCIL PACKET DURING A CITY COUNCIL MEETING, PLEASE HAVE COURTESY COPIES PROVIDED TO ALL COUNCILORS AND THE CITY MANAGER PRIOR TO THE RELEVANT WORK SESSION OF THE CITY COUNCIL MEETING. PLEASE IDENTIFY YOUR NAME AS PRESENTING THIS INFORMATION. IF YOUR MATERIALS INCLUDE DATA OR FACTUAL INFORMATION, PLEASE ALSO INCLUDE THE SOURCE, AUTHOR, AND PUBLICATION DATE. THIS GIVES US ALL A SHARED FOUNDATION FOR THOUGHTFUL DISCUSSION AND DECISION-MAKING DURING COUNCIL MEETINGS.

THESE UPDATES ARE NOT ABOUT LIMITING DIALOGUE — THEY'RE ABOUT STRUCTURING IT IN A WAY THAT SUPPORTS RESPECTFUL PARTICIPATION AND TRANSPARENCY. I APPRECIATE YOUR COOPERATION AS WE IMPLEMENT THEM.

I ALSO WANT TO SHARE SOMETHING I'VE COME TO UNDERSTAND MORE FULLY SINCE TAKING OFFICE. AS MAYOR, I'VE FOUND IT INCREASINGLY DIFFICULT TO HAVE CERTAIN OFFLINE CONVERSATIONS WITH COUNCILORS — NOT BECAUSE I DON'T WANT TO, BUT BECAUSE OF HOW OREGON'S ETHICS LAWS ARE CURRENTLY BEING INTERPRETED. UNDER THE CURRENT GUIDANCE, IF TWO COUNCILORS ARE ALREADY COMMUNICATING OFFLINE ABOUT A MATTER BEFORE THE COUNCIL, AND I NEED TO RAISE A PROTOCOL-RELATED CONCERN THAT POTENTIALLY TOUCHES ON THAT MATTER, I'VE CONCLUDED I CANNOT DO SO — EVEN THROUGH OUR CITY ATTORNEY — OUTSIDE OF A PUBLIC MEETING. THAT'S A SHIFT FROM TRADITIONAL PRACTICE AND ONE I HOPE THE LEGISLATURE EVENTUALLY CLARIFIES.

BUT FOR NOW, I WANT TO BE UPFRONT ABOUT HOW I'M NAVIGATING THIS IN GOOD FAITH.

FINALLY, I WANT TO ACKNOWLEDGE WHAT WE ALL KNOW TO BE TRUE — EACH OF US BRINGS OUR OWN LIVED AND PROFESSIONAL EXPERIENCES TO THIS ROLE & STYLES IN COMMUNICATING. THAT DIVERSITY OF PERSPECTIVE AND COMMUNICATION IS ONE OF OUR GREATEST STRENGTHS. IN MY CASE, HAVING SPENT YEARS

LITIGATING IN BOTH THE PRIVATE AND PUBLIC SECTOR,
ESPECIALLY IN EMPLOYMENT MATTERS, & ADVISING CLIENTS. I
TEND TO LEAN ON OBJECTIVE, CREDIBLE EVIDENCE OVER
ASSUMPTION OR CONJECTURE.

I ALSO BRING THE PERSPECTIVES OF A FATHER AND SMALL BUSINESS OWNER. JUST AS YOUR BACKGROUNDS SHAPE HOW YOU APPROACH YOUR WORK, MINE DOES TOO. AND THAT'S WHAT MAKES THIS COUNCIL PARTICULARLY STRONG AND THOUGHTFUL — OUR DIFFERENCES, WORKING IN CONCERT FOR THE COMMUNITY WE SERVE.

OVER THE PAST TWO WEEKS, I HAVE PARTICIPATED IN A NUMBER OF MEETINGS AND EVENTS WITH LOCAL AREA ELECTED OFFICIALS AND COMMUNITY MEMBERS, ALONG WITH MEETINGS WITH CONSTITUENTS. OIT IdeaFest

I attended Oregon Institute of Technology's annual Idea – Fest on Wednesday, June 4. This was an exciting opportunity to learn about incredible capstones, research, theses, and other class projects that their juniors, seniors, and graduate students are working on. I would encourage everyone to

IdeaFest includes project posters and demonstrations from students in computer science, electrical engineering, manufacturing and mechanical engineering, and renewable energy engineering.

OIT invites prospective students and other guests to attend for an up-close look at highly inventive and innovative projects Oregon Tech students are creating.

Washington County Coordinating Committee (WCCC)

On June 9, I attended the Washington County Coordinating Coordination meeting. We heard from Metro regarding their Comprehensive Climate Action Plan that they are working on which will include current emissions levels, targets to reduce emissions as a state, and actions that the region can take to mitigate and reduce climate change.

Metro also provided a presentation regarding Metro' Regional Flexible Fund allocation for 2028- 2030. I expressed support for completing the projects on the list so that future funds can be allocated to the Boone Bridge project.

2025 Westside Economic Alliance Mayor's Forum and Reception Speaking of mayors' meetings, I was honored to join fellow Mayors to speak at the Annual Mayor's Forum hosted by the Westside Economic Alliance (WEA) on June 12.

I spoke alongside fellow mayors from Beaverton, Cornelius, Tigard, Tualatin, Sherwood, and West Linn. I had the opportunity to discuss housing affordability, infrastructure, the pending transportation package at the Oregon Legislature, and other related topics. While personalities and opinions were as different as these 7 cities, there were a few common themes. Cities across the state and region are facing constrained budgets as expenses outpace revenues. There is a growing desire to have an honest, and frank conversation about comprehensive tax reform in Oregon. Our current system is not working. As leaders we need to be asking for a system that positions both the state and its constituent cities for success. On a related note, Mayors were also united in a desire for fewer state mandates, and more funding support for infrastructure in order to facilitate housing and economic development, speed to market, and affordability.

Joint Policy Advisory Committee on Transportation

On June 12, Transit Director Dwight Brashear and I provided testimony at the Joint Policy Committee on Transportation (JPACT) to express the importance of SMART and other transit agencies having direct representation at the JPACT table. I advocated that it should not be the responsibility of our Clackamas County and Clackamas County City representatives to intimately understand the challenges and operations of a public transit agency. Our Clackamas County Representatives on JPACT echoed the need for SMART and

other small transit agencies to have a seat at the JPACT table as they do not have the staff support to adequately represent the needs of transit agencies.

I also expressed that the only way to actually increase public transit utilization, and make headway on achieving key Regional Transportation Plan goals to reduce vehicle miles traveled and GHG emissions, and increase highway capacity for the timely movement of freight is for regional transit agencies, including SMART, to have equal footing with TriMet.

A decision was not made but there may be an interest in a Metro led working group to explore this further, which is a step in the right direction, and I will continue to advocate for additional representation at JPACT.

Legislative Update

I WILL ONLY NOTE THAT TODAY IS THE 147TH DAY OF THE 160-DAY SESSION & ONE OF THE MOST CRITICAL THINGS REMAINING IS A BALANCED STATE BUDGET FOR THE 2025-27 BIENNIUM NEEDS TO BE COMPLETED & A TRIP 2025 OMNIBUS TRANSPORTATION BILL WHICH HOPEFULLY WILL MOVE FORWARD.

I would also like to provide a few legislative updates

- Today [Monday, June 16th] is the 147th day of the 160-day session, with just 13 days left before the Constitutional Sine Die, on June 29. The targeted Sine Die is this Friday, but the session is likely to go until the last possible day.
- Although we are in the final days of the legislative session, there are many important bills and budgets still under consideration:
 - A balanced State Budget for the 2025-27 Biennium needs to be completed.
 - The TRIP 2025 Omnibus Transportation Bill needs to be completed. Last week, I provided testimony on this 10year plan for Oregon Transportation.
 - I expressed our support for: the seismic rebuilding of the Boone Bridge, funding for transportation maintenance and operations, essential reforms for transit services, and our long-term efforts to extend the WES service to Salem and other communities in the Willamette Valley.
 - I expressed our concern about maintaining the "50% -30% - 20%" allocation of fuel tax revenues so that money from Oregon's gas tax is equitably distributed to support the entire transportation system - State Highways, County Roads and City Streets - all of which need funding to maintain a system that meets the

needs of all Oregonians. Wilsonville voiced strong support for this current allocation system.

- A dozen or so other critical issues are under active legislative consideration, including bills concerning tourism, prevailing wages on public projects and bills relating to water rights, to name a few.
- Working in coordination with the League of Oregon Cities, our city staff has been tracking and providing input on dozens of legislative issues, including Housing, Infrastructure Funding, and other city priorities.
- Final decisions on funding for projects the city has requested will be made shortly as the 2025 Session of the Oregon Legislature comes to a close at the end of June.
- In these last busy days, we will continue to have our voice heard in the State Capitol in Salem on the issues of importance to the City of Wilsonville.

I WANT TO TAKE A MOMENT TO DIRECTLY ADDRESS THE CONCERNS SOME RESIDENTS HAVE RAISED ABOUT PUBLIC SAFETY AND THE SMART BUS LINE EXTENSION TO CLACKAMAS TOWN CENTER — A TOPIC THAT HAS COME UP DURING OUR CITY COUNCIL DISCUSSIONS REGARDING THE CITY BUDGET WE JUST ADOPTED.

LET ME BE CLEAR: PUBLIC SAFETY IS — AND WILL ALWAYS BE — A TOP PRIORITY. I TAKE THAT SERIOUSLY, NOT JUST AS YOUR MAYOR, BUT AS A NEIGHBOR, A PARENT, AND SOMEONE WHO HAS CALLED WILSONVILLE HOME FOR NEARLY TWO DECADES.

WHEN I CONSIDER ISSUES LIKE THIS, I BRING MY PERSONAL AND PROFESSIONAL EXPERIENCE TO THE TABLE — AND I DO MY BEST TO FOCUS ON FACTS, NOT FEAR.
