MAYOR'S BUSINESS [7:20 PM]

Good evening. I hope everyone had a safe, fun Halloween trick-ortreating in Wilsonville's neighborhoods. MAPS Credit Union Ribbon Cutting

On October 22, I attended the ribbon cutting for a new business in Wilsonville—MAPS Credit Union, which opened a branch in Town Center. As part of that grand ribbon cutting, they made a sizable donation to the Wilsonville Community Sharing, which was a critical need for our local food bank and social services non profit. Thank you to the Wilsonville Chamber of Commerce for helping organize the event.

On that same week, I had a meeting with Representative Rieke Smith discussing various issues including needed legislative support for economic development here in Wilsonville.

At the end of that week I met with Superintendent Kathy Lutwig, and West Linn Mayor Rory bee-ah-lo-STOSS-kee (Bialostosky). This is an annual meeting held with the Superintendent, and the City leaders of the Cities the School District serves. The City of Wilsonville has had a historic strong relationship with the District. The discussion was focused on recent events, and the ongoing partnership we have.

DC Trip

From early Monday through late Thursday, I led Wilsonville's first independent trip to Washington, D.C. — representing our city directly rather than as part of a regional delegation, where our message often gets lost. I was joined by Assistant City Manager Jeanna Troha and Government Relations Manager Everett Wild, whose preparation and coordination were instrumental to the success of our meetings.

On Capitol Hill, we met with Senator Jeff Merkley, Congresswoman Andrea Salinas, and senior staff for Senator Ron Wyden, along with key officials from the U.S. Department of Transportation and the Federal Aviation Administration. I also met separately with Senator Wyden later in the week.

City discussions focused on several critical issues including:

- Securing federal support for the Boone Bridge replacement, a vital link for our residents, workforce, and international commerce.
- Expanding housing and utility infrastructure funding to support student and worker housing.
- Ensuring proper oversight of the Aurora Airport Master Plan to protect safety and transparency.

In addition, I raised broader concerns shared by many Wilsonville residents — including the local impact of federal funding cuts, rising corporate-controlled residential and commercial rents, and recent ICE activity in Wilsonville that has heightened fear among immigrant and other marginalized families.

We also met with Oregon Institute of Technology President Dr. Nagi NA-ga-na-than (Naganathan) and his team, who were in D.C. on other matters, to discuss student enrollment growth and housing needs — both vital to Wilsonville's future workforce and the continued success of Oregon's next-generation industries.

This trip marked an important step in ensuring Wilsonville's unique voice — as a hub for innovation, employment, and opportunity — is heard at the national level. I'm deeply grateful to our federal partners, and most especially to Jeanna and Everett for their outstanding work advancing our city's goals.

Also, many thanks to the participants who donated to **Wilsonville Community Sharing** while dropping off their bulky items. Residents donated **over \$4,400 dollars**, which will go to support neighbors in need and reduce hunger in our community.

Ruby Bridges Walk to School Day

On November 14, 1960, **Ruby Bridges** became the first African-American to integrate in a southern public school. Despite the Supreme Court's landmark ruling *Brown v. Board of Education* in 1945, southern states were resistant under Jim Crow laws. It took another federal court ruling to get Louisiana schools to integrate, and at 6 years old, Ruby Bridges attended her first day of school at Frantz Elementary in New Orleans.

On **Friday, November 14**, join **SMART and the Oregon Safe Routes to School program** to celebrate **Ruby Bridges Walk to School Day**, which gives students the chance to celebrate Ruby's courage and learn about the Civil Rights movement by walking to school.
