RESOLUTION NO. 3218

A RESOLUTION OF THE CITY OF WILSONVILLE ADOPTING THE CLIMATE ACTION PLAN.

WHEREAS, the City Council goals for FY 2023-25 included developing Wilsonville's Climate Action Plan (the "Plan"); and

WHEREAS, the City has developed this Plan to support and enhance its existing municipal and regional strategies and to ensure alignment with the State of Oregon's greenhouse gas reduction goals. These goals are to reduce emissions across all sectors and communities in Oregon by at least 45% by 2035 and by 80% by 2050; and

WHEREAS, the Plan identifies ten significant climate actions in five areas that constitute a pathway for Wilsonville to reduce its greenhouse gas emissions by 58% by 2035 and 83% by 2025; and

WHEREAS, the Plan ensures that all who live and work in Wilsonville can benefit from this transition by increasing the number of good, long-term jobs, making home ownership and transportation more affordable and healthier, and by supporting both the social and natural resilience of the community; and

WHEREAS, the Plan emphasizes the role of the City as a leader – decarbonizing its own operations, stimulating the development of skills in the local labor force, ensuring Wilsonville's economy attracts strong industries and ensuring the community's future is healthier, greener, and more resilient; and

WHEREAS, to gather public input, the project team conducted public outreach, hosted a public open house and business and industry forum, and conducted three online surveys; and

WHEREAS, the Planning Commission held three public work sessions and the City Council held three public work sessions to review and provide input on the project; and

WHEREAS, on October 8, 2025, the Planning Commission of the City of Wilsonville, who under city code has the authority to review and make recommendations to the City Council, conducted a public hearing on the Climate Action Plan and forwarded a unanimous recommendation of approval; and

WHEREAS, the City Council has duly considered the subject, including the staff recommendation and all the exhibits and testimony introduced by interested parties.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

Section 1. The Wilsonville City Council hereby adopts the Climate Action Plan as presented at the November 3, 2025, public hearing, including the findings and recommendations contained herein.

Section 2. This Resolution is effective upon adoption.
